City of Lethbridge Capital Budget

Introduction

Lethbridge's Capital Improvement Program, or CIP, is a plan that identifies capital investment projects and provides a planning schedule and financing plan. All CIP projects are approved by City Council. The City of Lethbridge is currently in the process of planning for its next CIP (2022-2031). The Economic Standing Policy Committee of Council will deliberate projects for the draft 2022-2031 CIP budget during the week of May 10-14, 2021. Following this, Lethbridge City Council will ultimately decide which projects to prioritize over the next 10 years.

From April 14 to April 28, 2021, the City used the Ethelo platform to ask residents for their input on Lethbridge's CIP, encouraging them to express their support or opposition for various capital projects, and provide comment on each as well. The engagement educated residents on the City's proposed Capital Projects, as well as gathering input and gauging the priorities of participants.

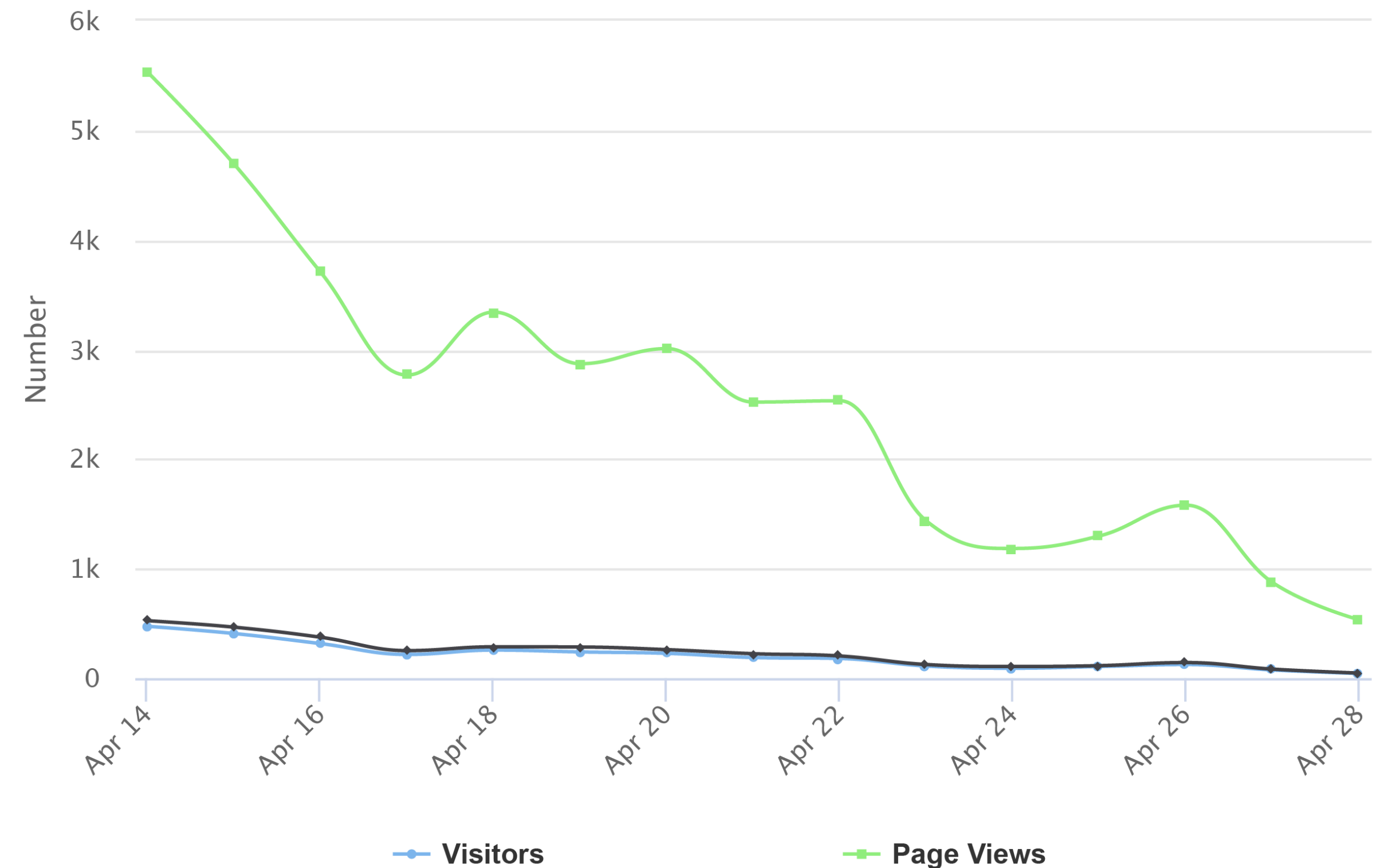
Feedback gathered during this process will be presented to the City Council for consideration as they deliberate around the 2022-2031 CIP budget.

This engagement boasted exceptionally high participation levels in comparison to engagements from similarly sized municipalities. Particularly, viewer numbers, voter numbers, and the average time spent on platform were all impressive metrics. This shows:

- residents of Lethbridge care about what happens in their community
- residents of Lethbridge are connected to the community they live in

The Ethelo platform took all participant input into account and identified projects that have low support, and high levels of polarization. These projects are most likely to encounter public opposition and risk failure.

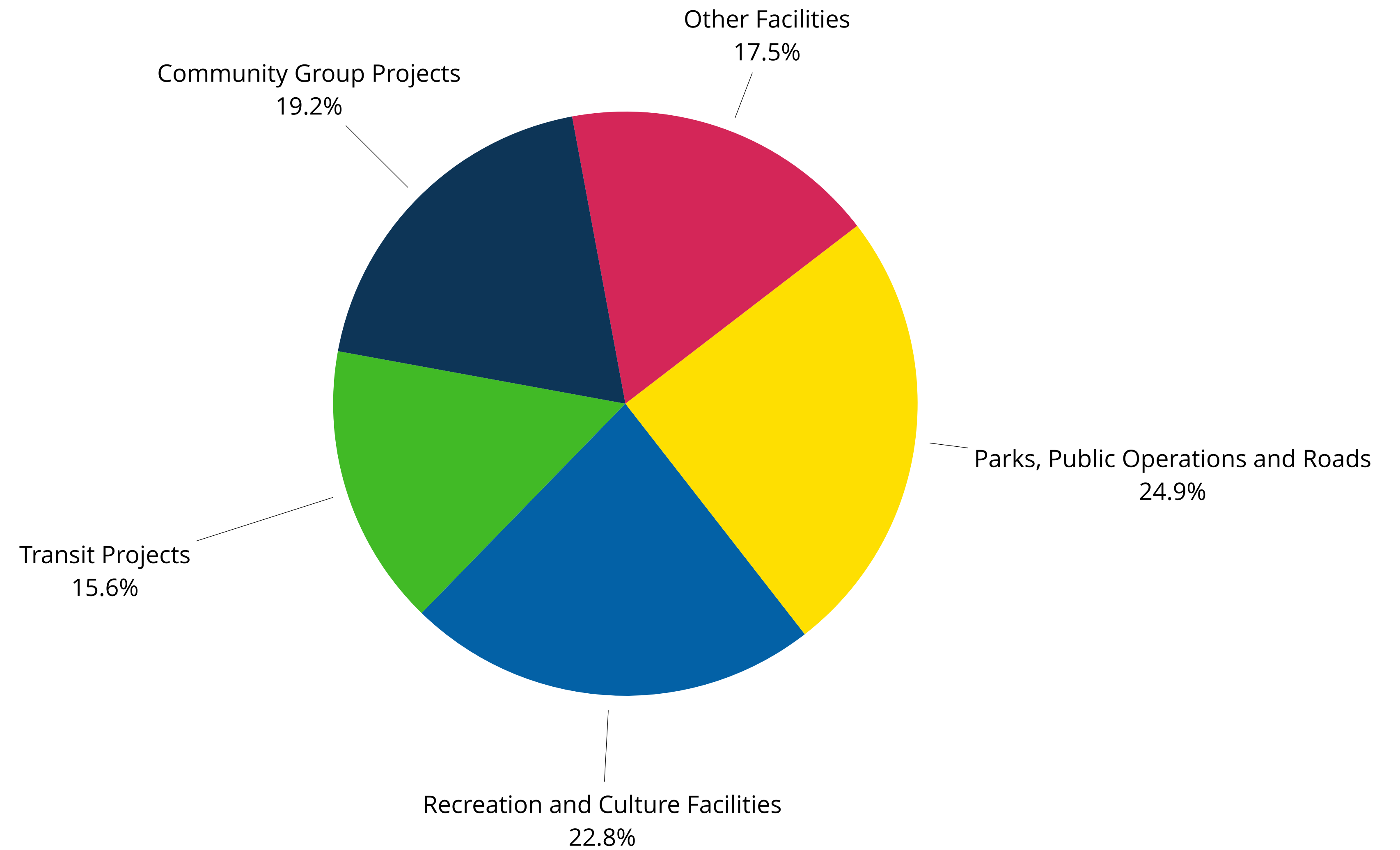

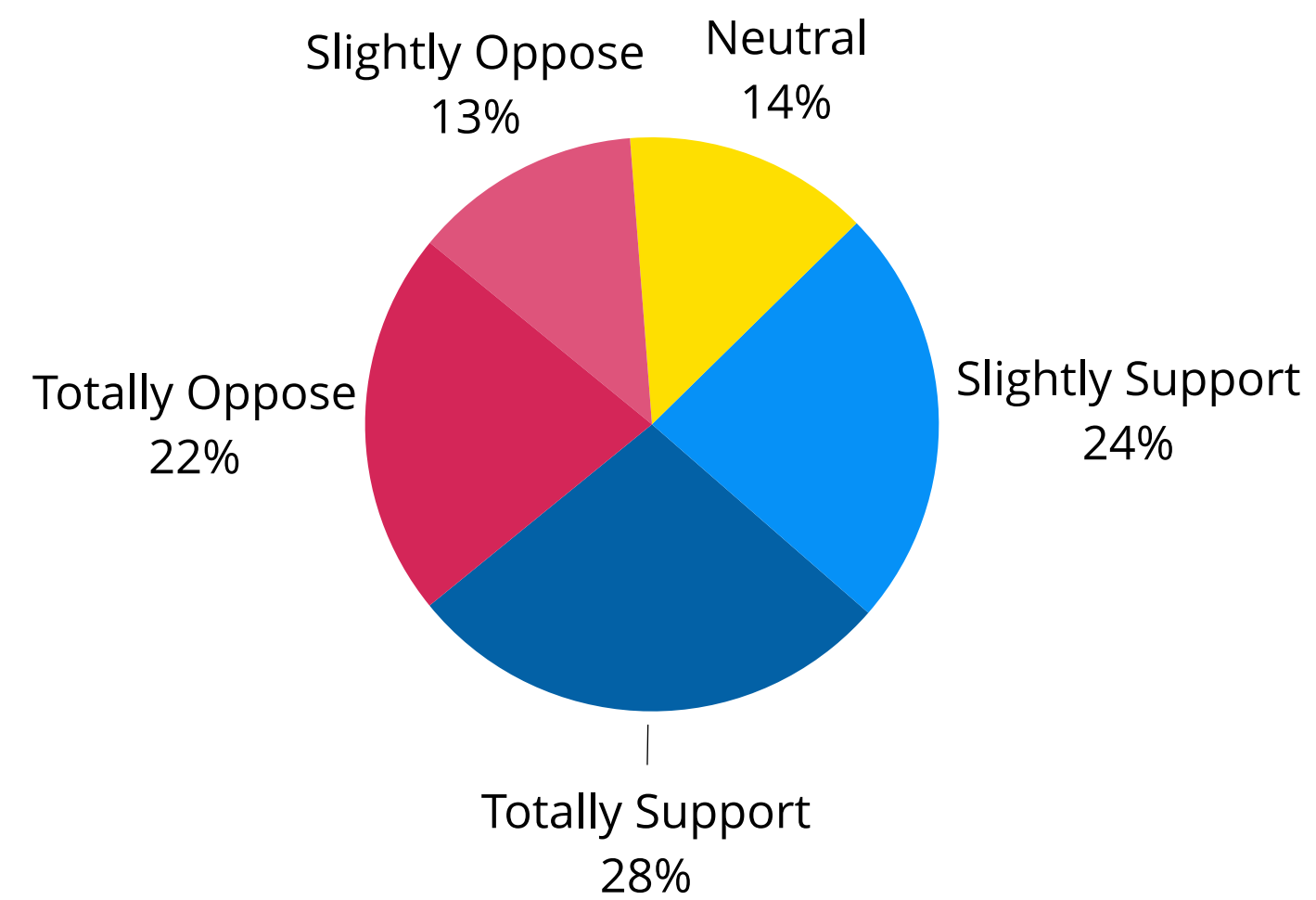

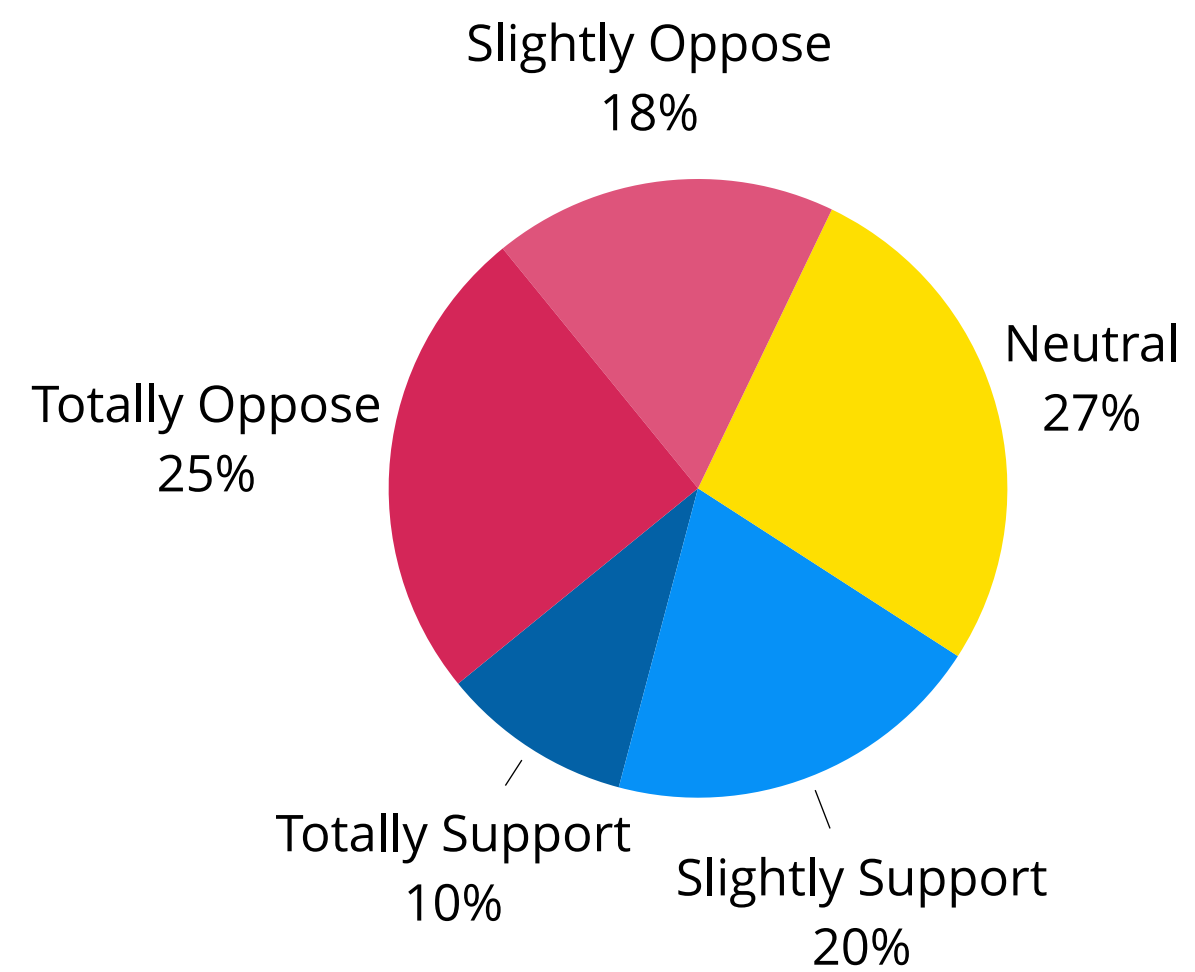

Most Supported: Electric Bus and Charging Infrastructure (56%)

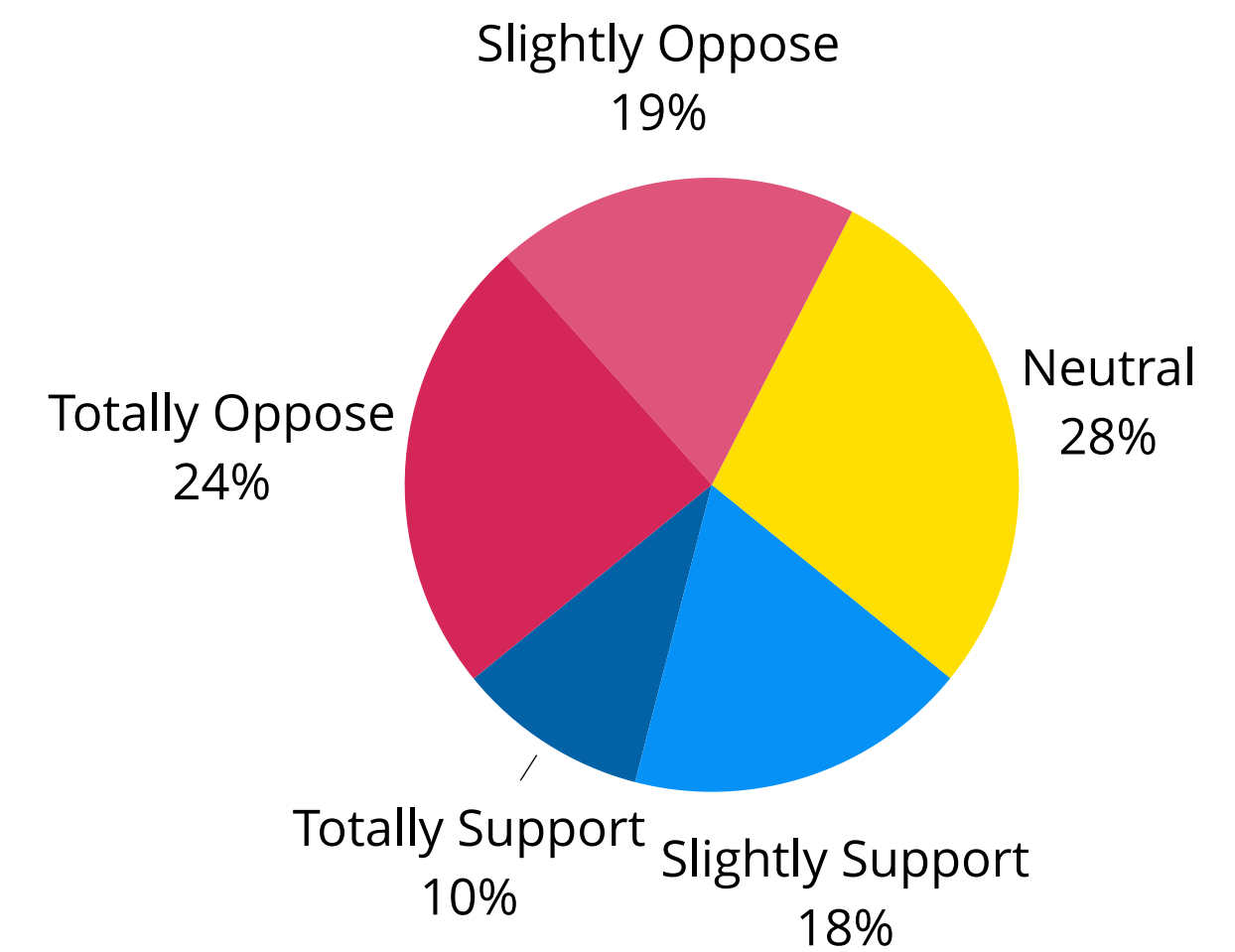

Electric Bus and Charging Infrastructure

How about introduce a couple of buses first to work out the bugs? That's a huge amount of money to spend on 'estimates' and 'approximates'. Things often work out differently on paper. The operating cost savings are virtually irrelevant compared to the capital cost.

I support this as long as we are replacing buses at the rate of attrition rather than just paying to get rid of perfectly serviceable vehicles. I appreciate diesel vs electric, but unless there is a buyer for the diesel buses why would we replace functioning vehicles?

The city should be looking at smaller buses for most routes. You have the busier ones, heading to and from the west side, university and college. But the rest run empty. Look into smaller buses that are electric.

Transit Terminals

I would support the Exhibition grounds, but Enmax has the college right beside it with a bus terminal and facilities there. I would support extending bus service to the Enmax on nights where there are large events, same with the Ex, assuming it sees an increase in use.

Does the ridership to these locations warrant the investment?

Huge cost for bathrooms for Transit Operators. Our current busing system costs the taxpayers nearly \$1 million per month. Rider usage does not warrant this level of expenditure.

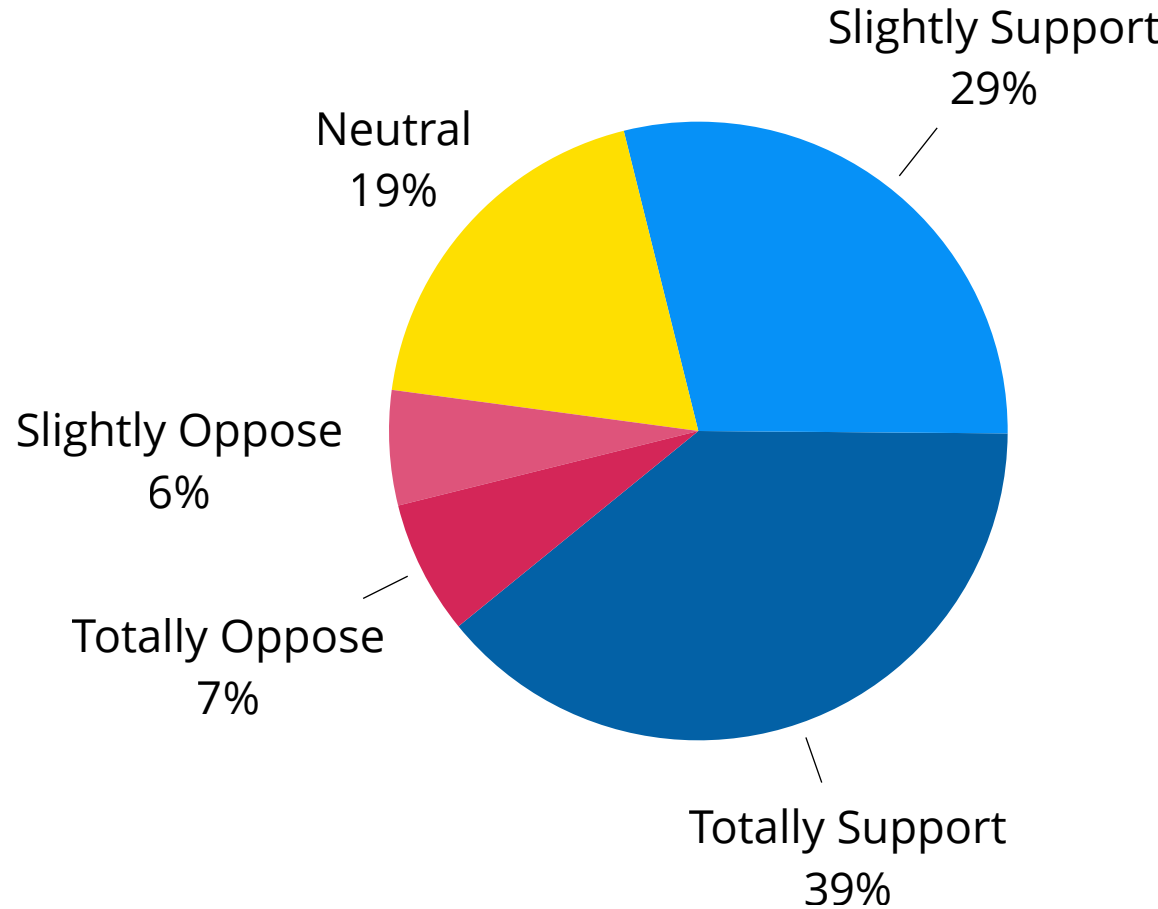

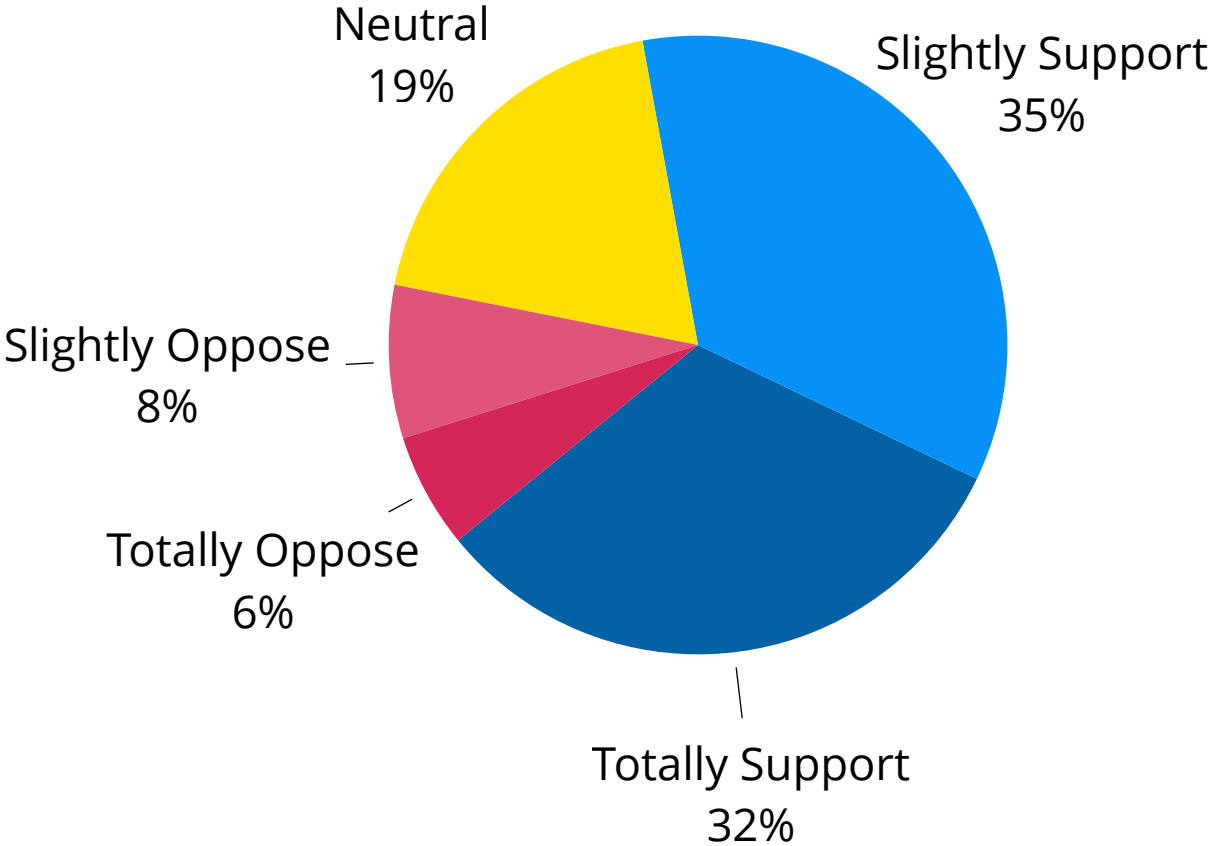

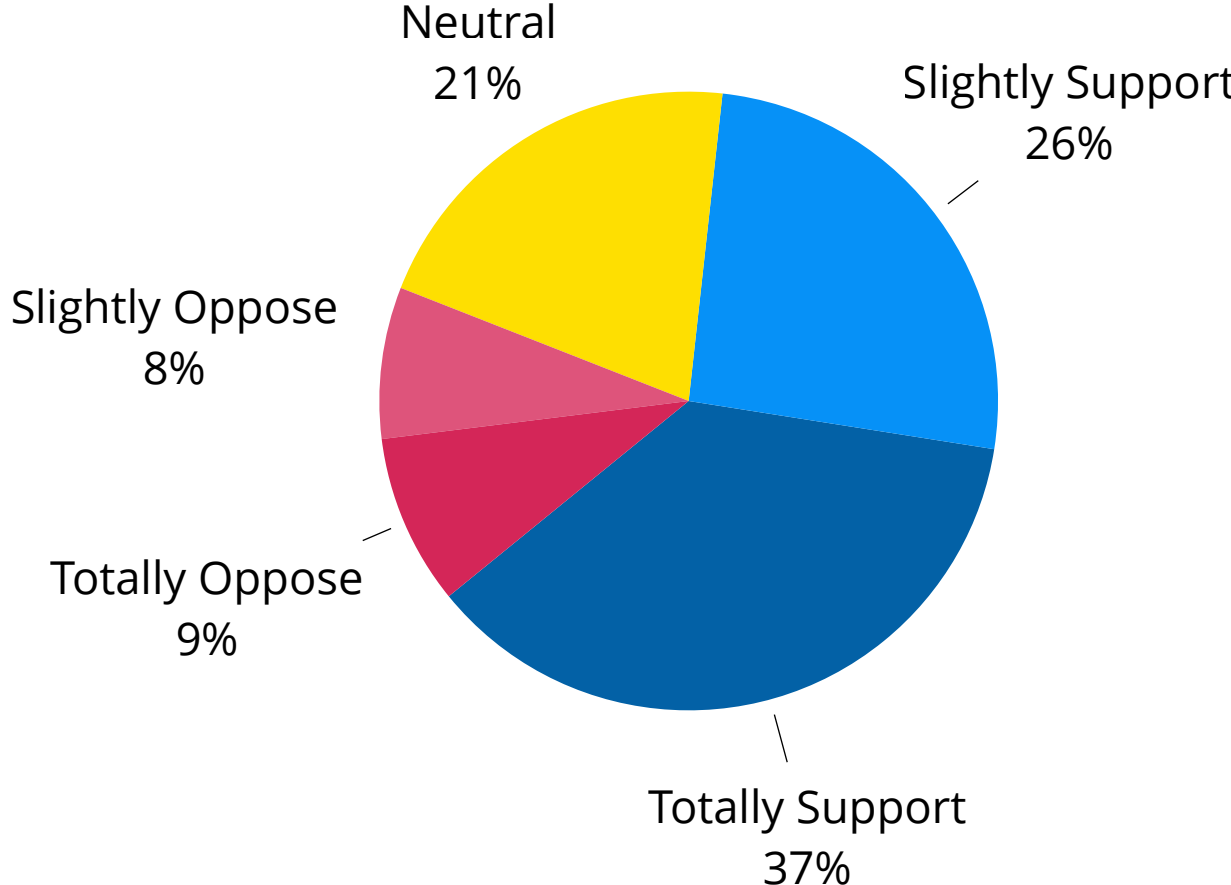

Fire Station #3 Relocation



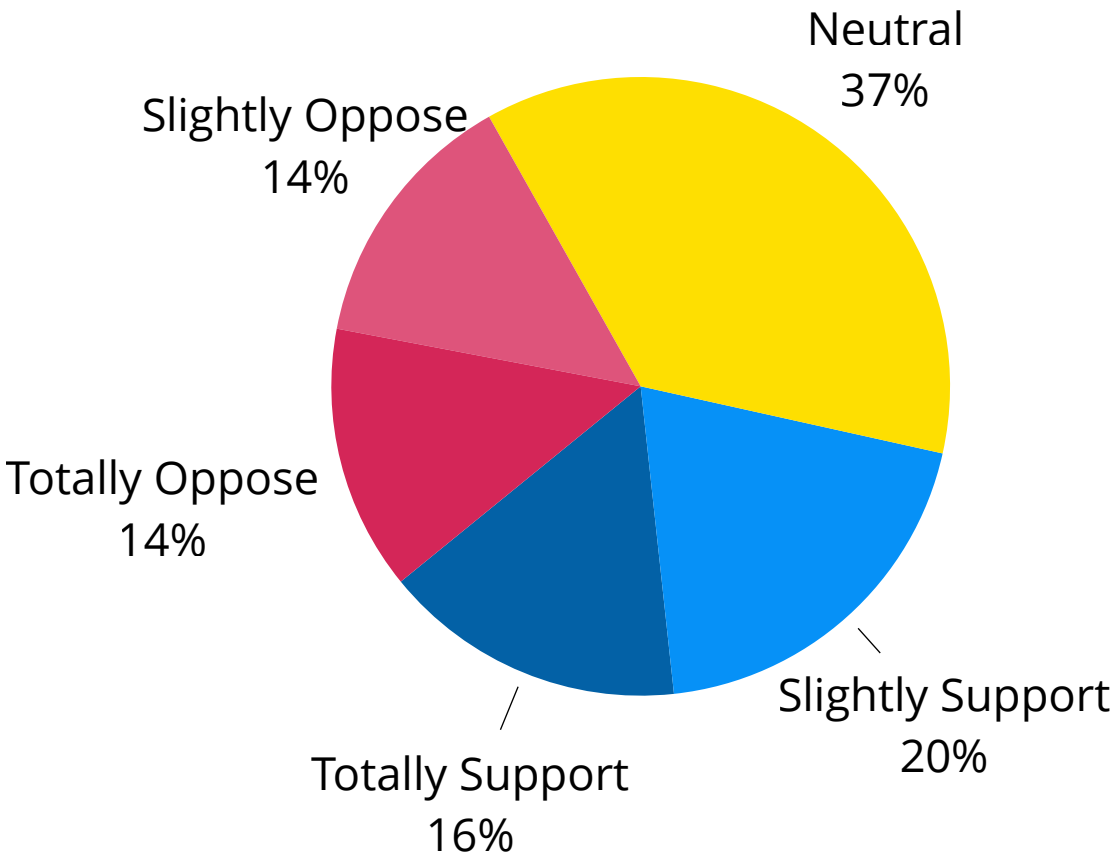

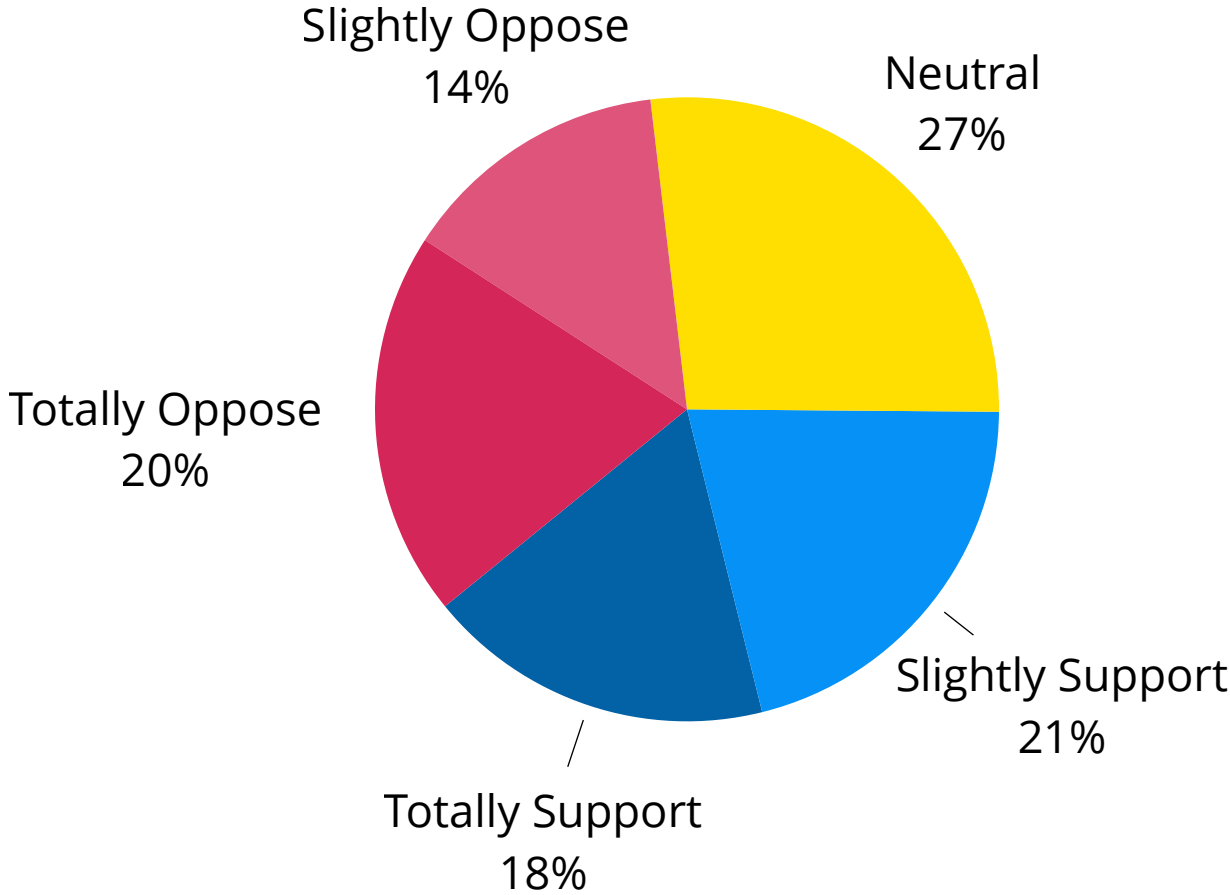

Downtown needs serious investment, but this is too vague to get behind. The best investment in downtown Lethbridge would be housing our homeless population, period.

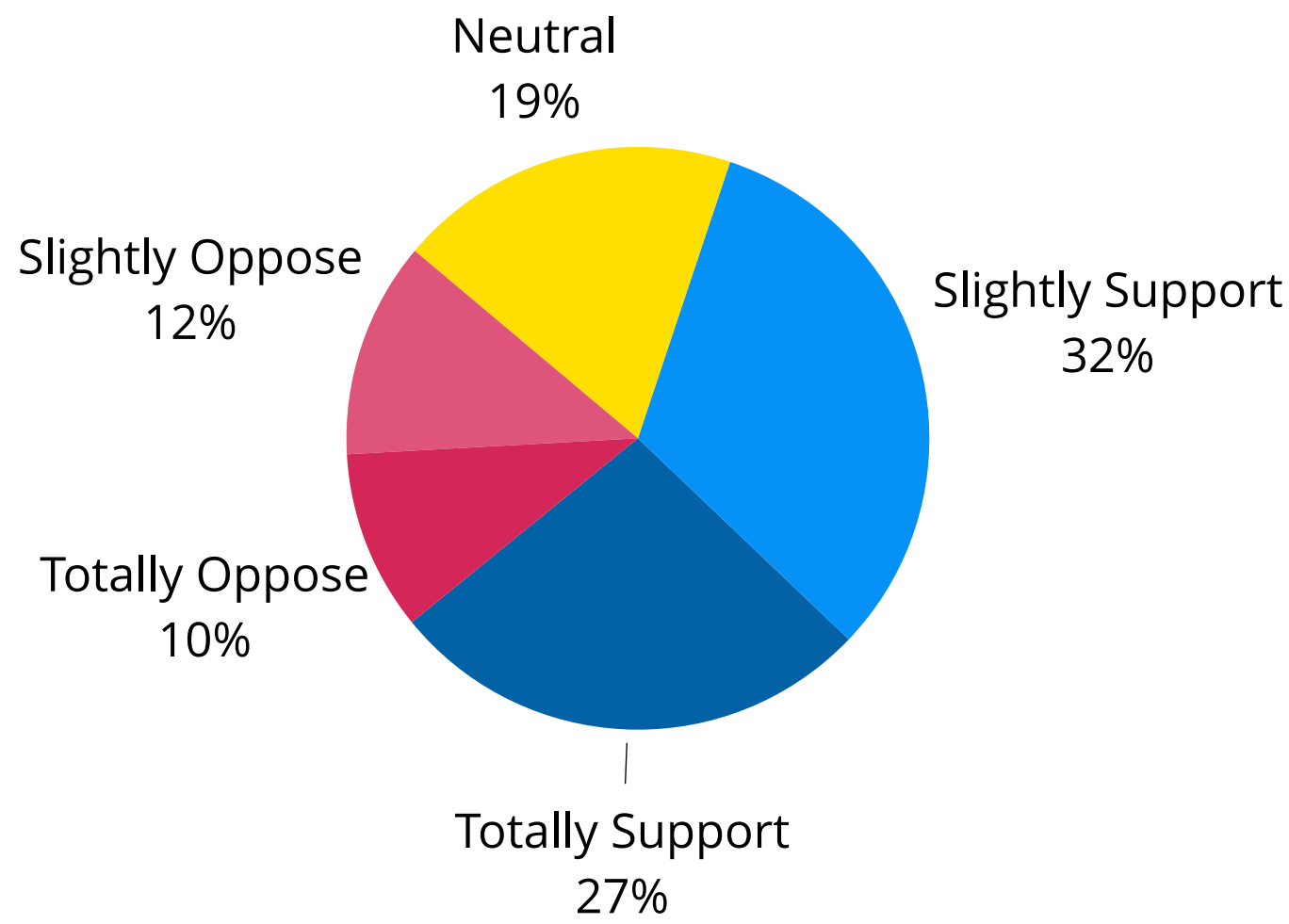

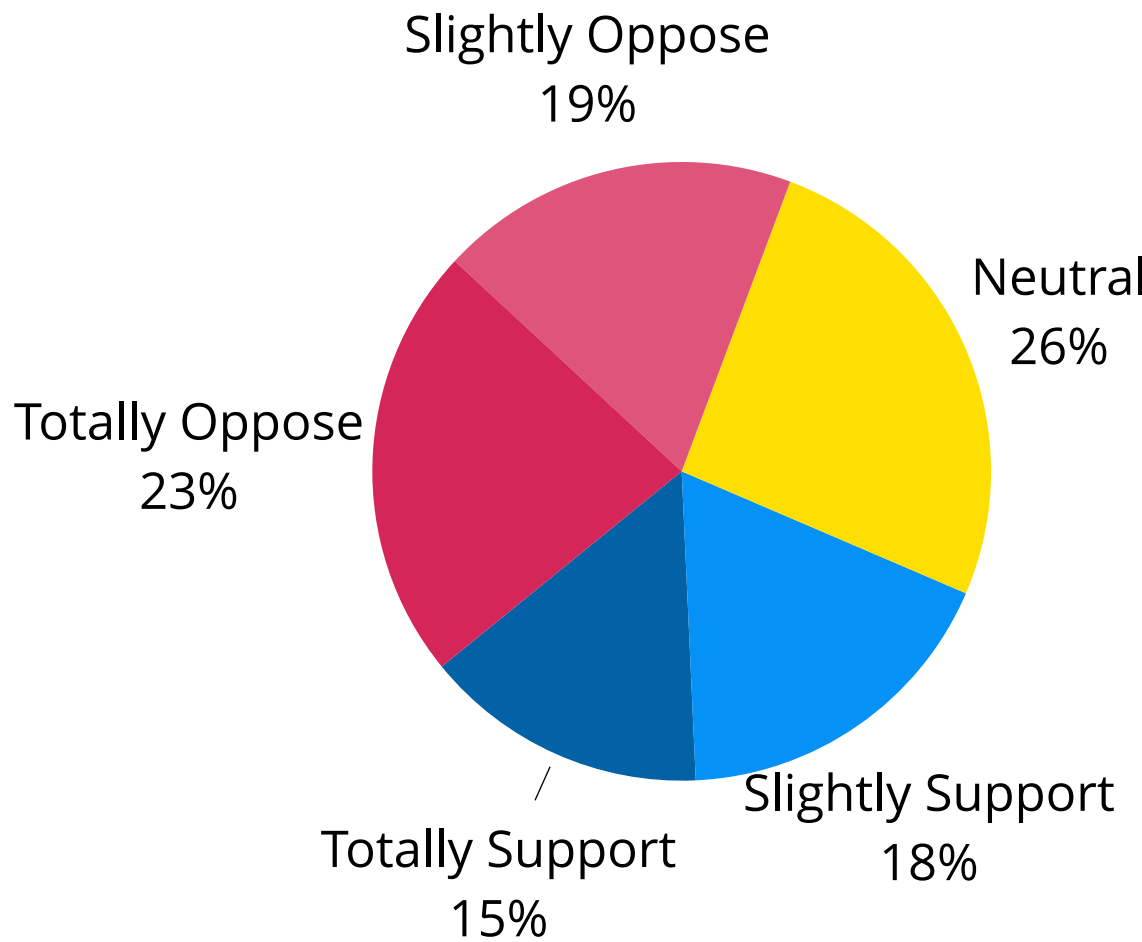

Southern Alberta Art Gallery (SAAG) Facility Enhancements

The SAAG is, in all realism, a private facility for a small group of people. Every event is generally the same, small crowd. Why food services when there are a half dozen restaurants in throwing distance?

It is easy to fall into the trapping of "I don't use that place" but a City's ability to attract and retain an investing population is dependent on having strong recreation and cultural opportunities for them to enjoy.

We have supported art projects with SAAG and CASA in previous budgets. Time to put our tax money toward other community interests.

Galt Gardens Pickleball Courts

I like the idea of bringing an activity to Galt Gardens and creating a more positive space. However, I don't agree that Pickleball is the right activity, I would like to see an activity that is more inclusive of the rest of the community.

It would be a great way to encourage more people to spend time downtown!

Public money should not fund spaces for exclusively private clubs. Though SOME of those courts will be available to the public, they can only be used for the ONE sport. Any public project should have multiple uses for multiple groups of citizens.

Great partnership and good value IF the school is open for the space to be utilized by the broader community. If utilized only for school population then public dollars shouldn't go to it.

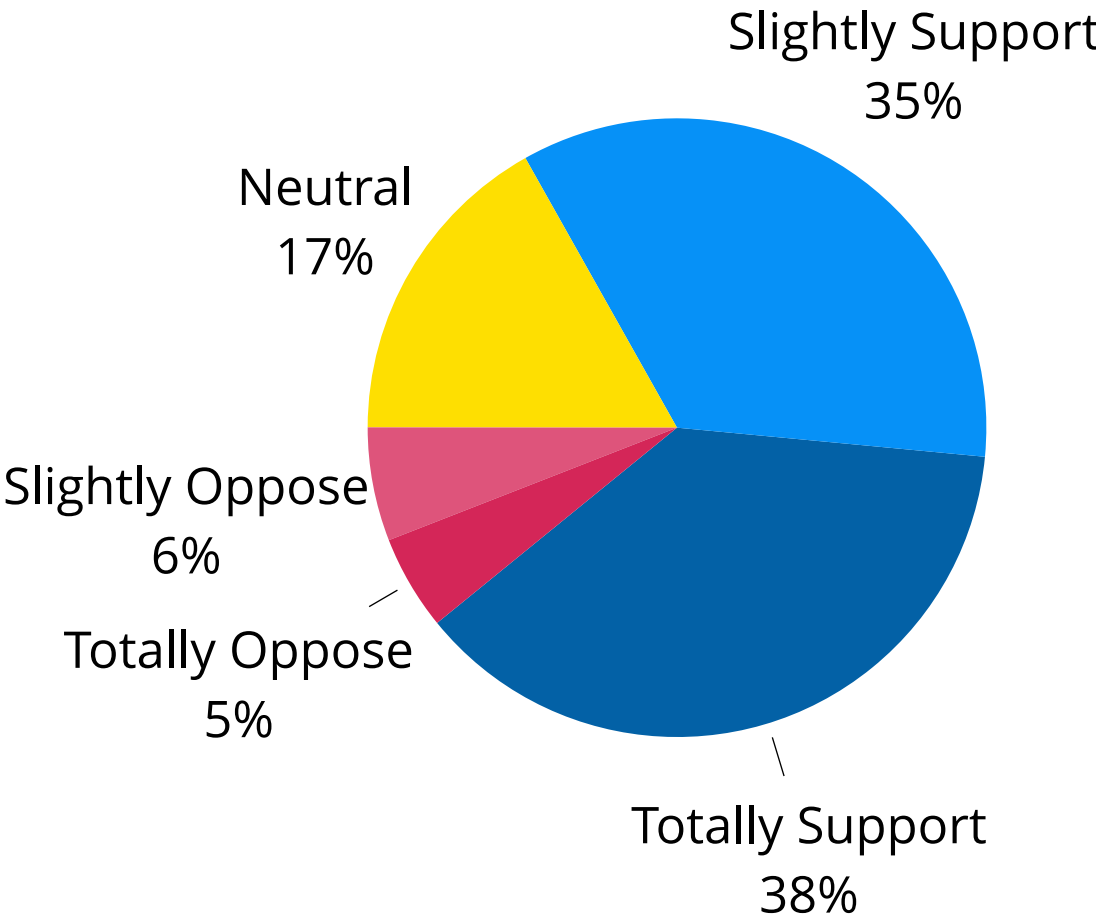

Henderson Ice Centre Upgrades

Arena Replacement

Indigenous people face ongoing racism and discrimination in this city. In the context of reconciliation, this is a worthwhile investment.

Nikka Yuko Japanese Garden (NYJG) Pathway

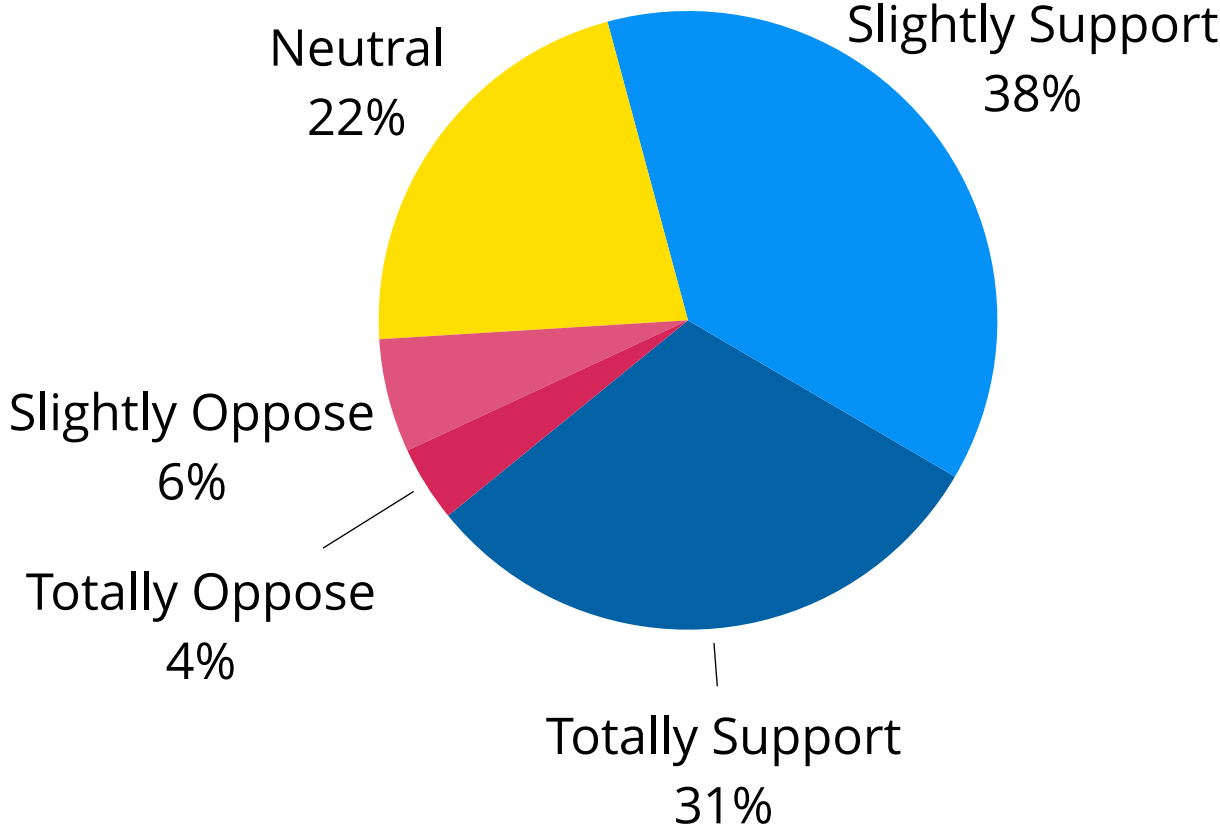

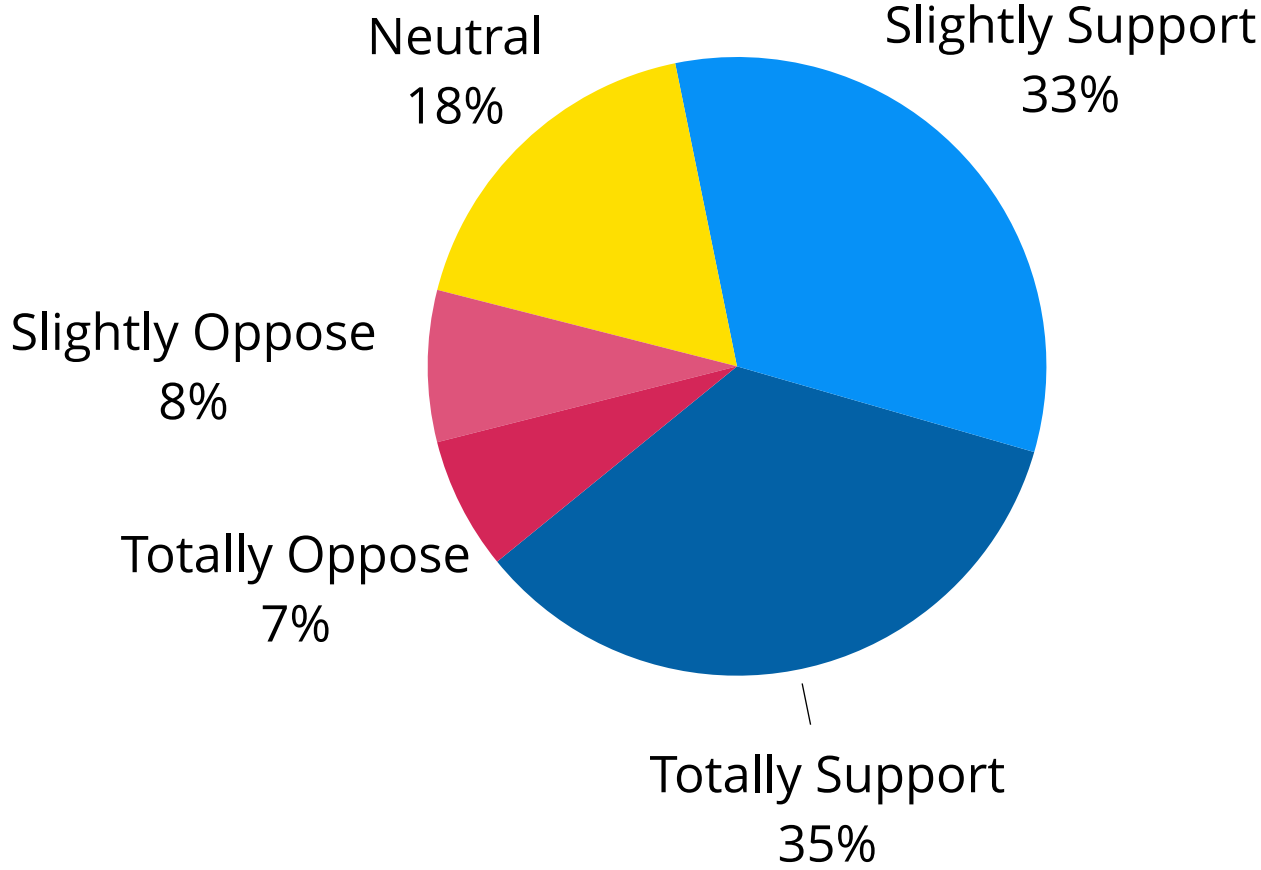

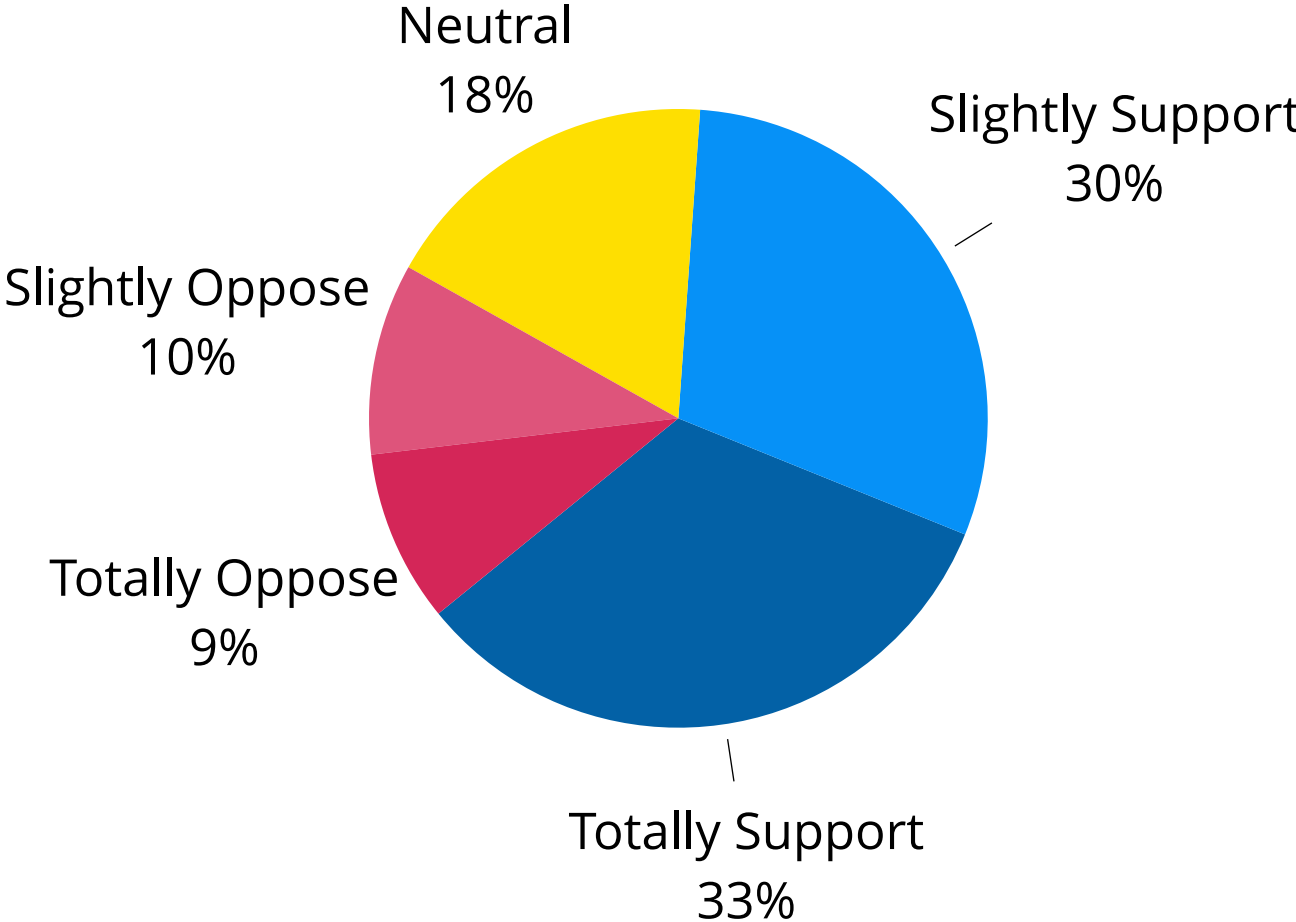
Parks Central Control Irrigation

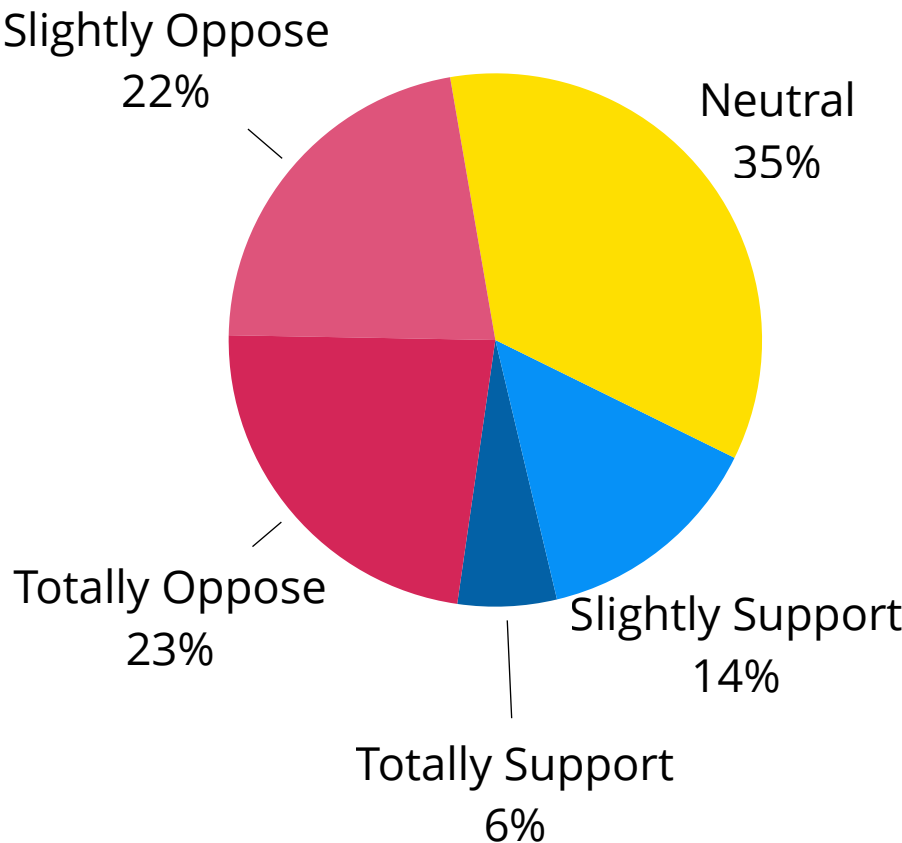

Parks, Public Operations and Roads

Add sustainable landscaping, zero scaping and tie in moisture sensors so the parks are not being watered when it's rained for 3 days.

Parks Asset Management

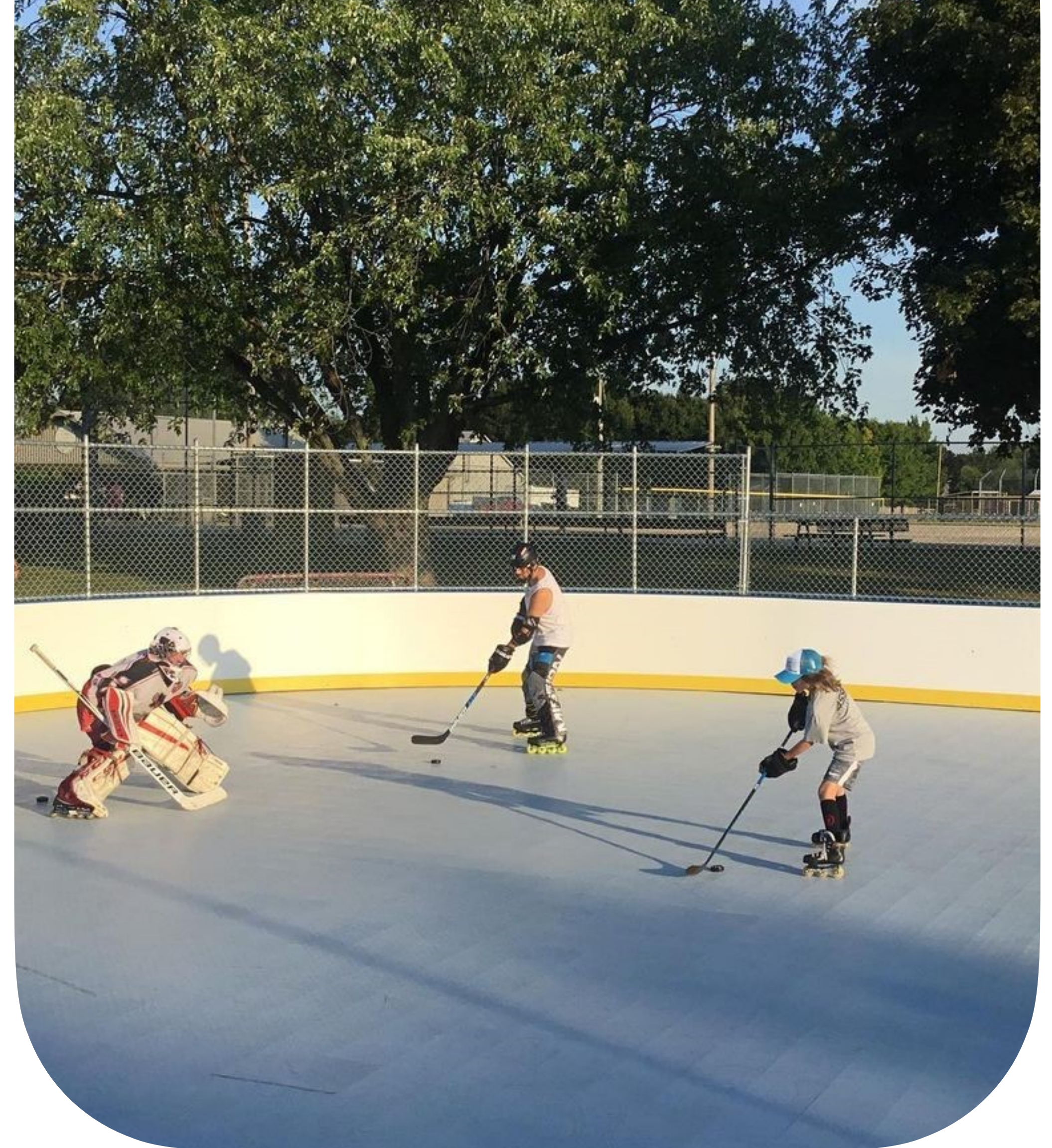
West Lethbridge Operations Depot (Phase 3a)

Are these required? Seems rather costly.

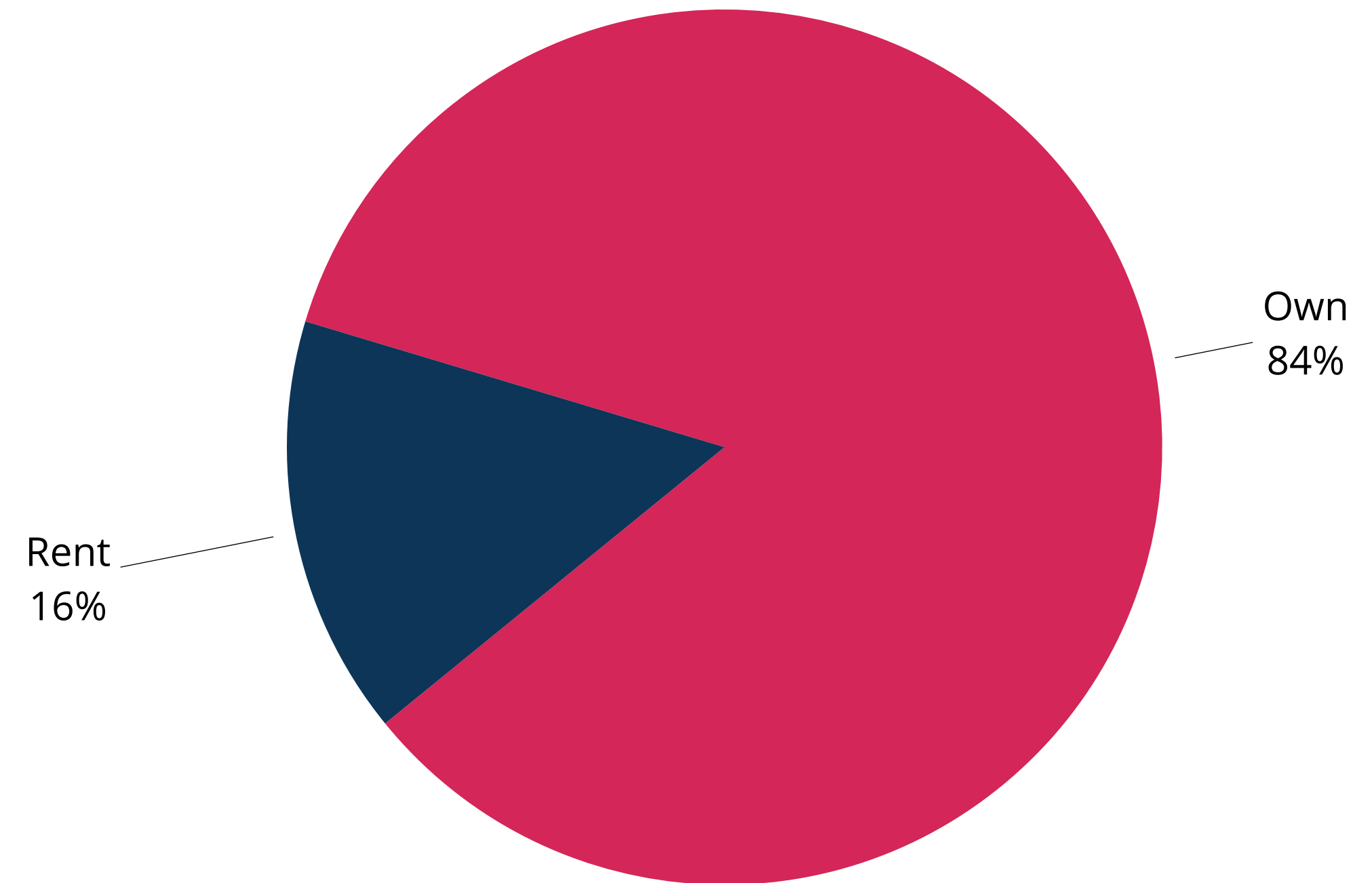

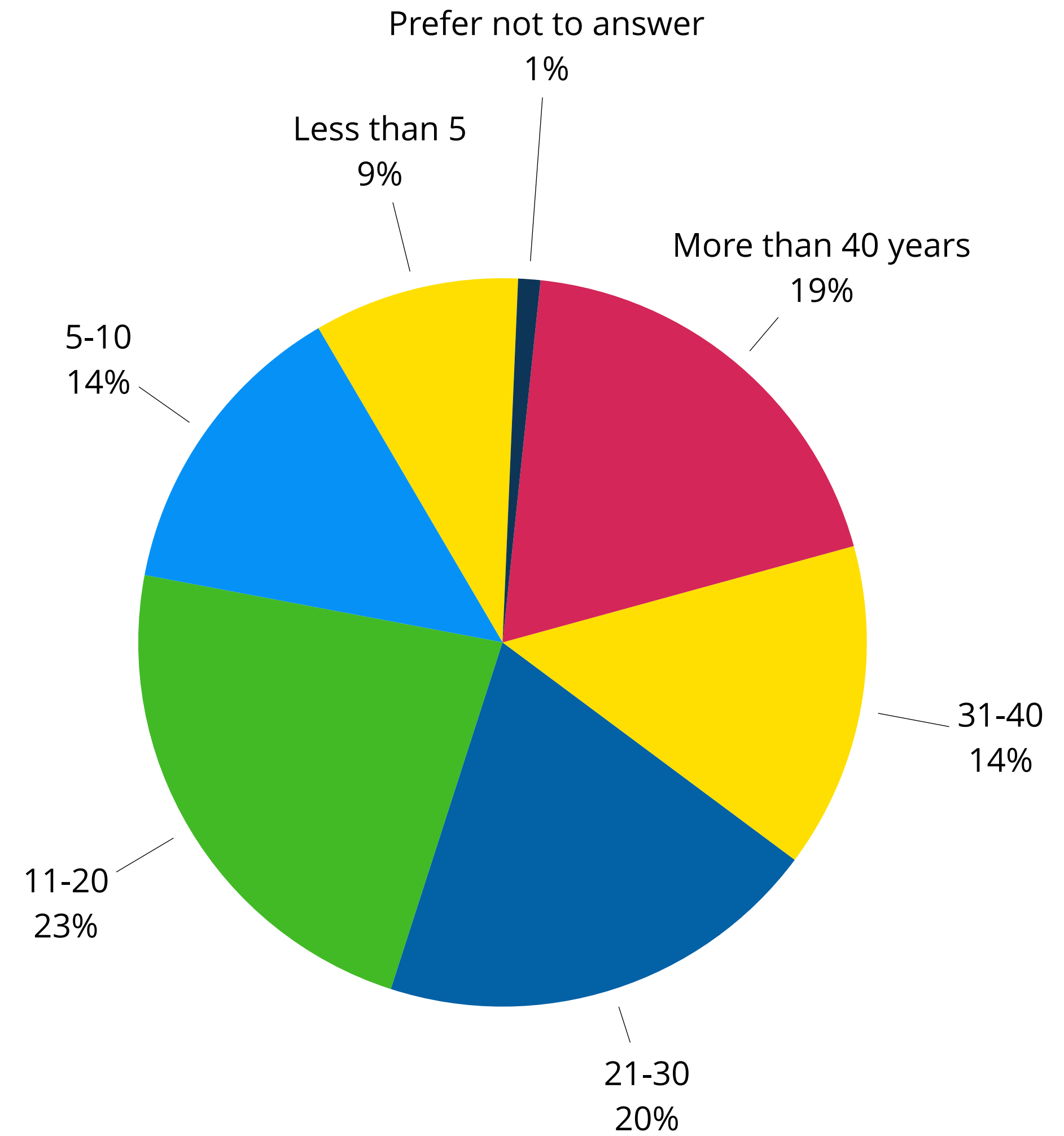

Participants were asked to indicate **whether they rent or own their home.**



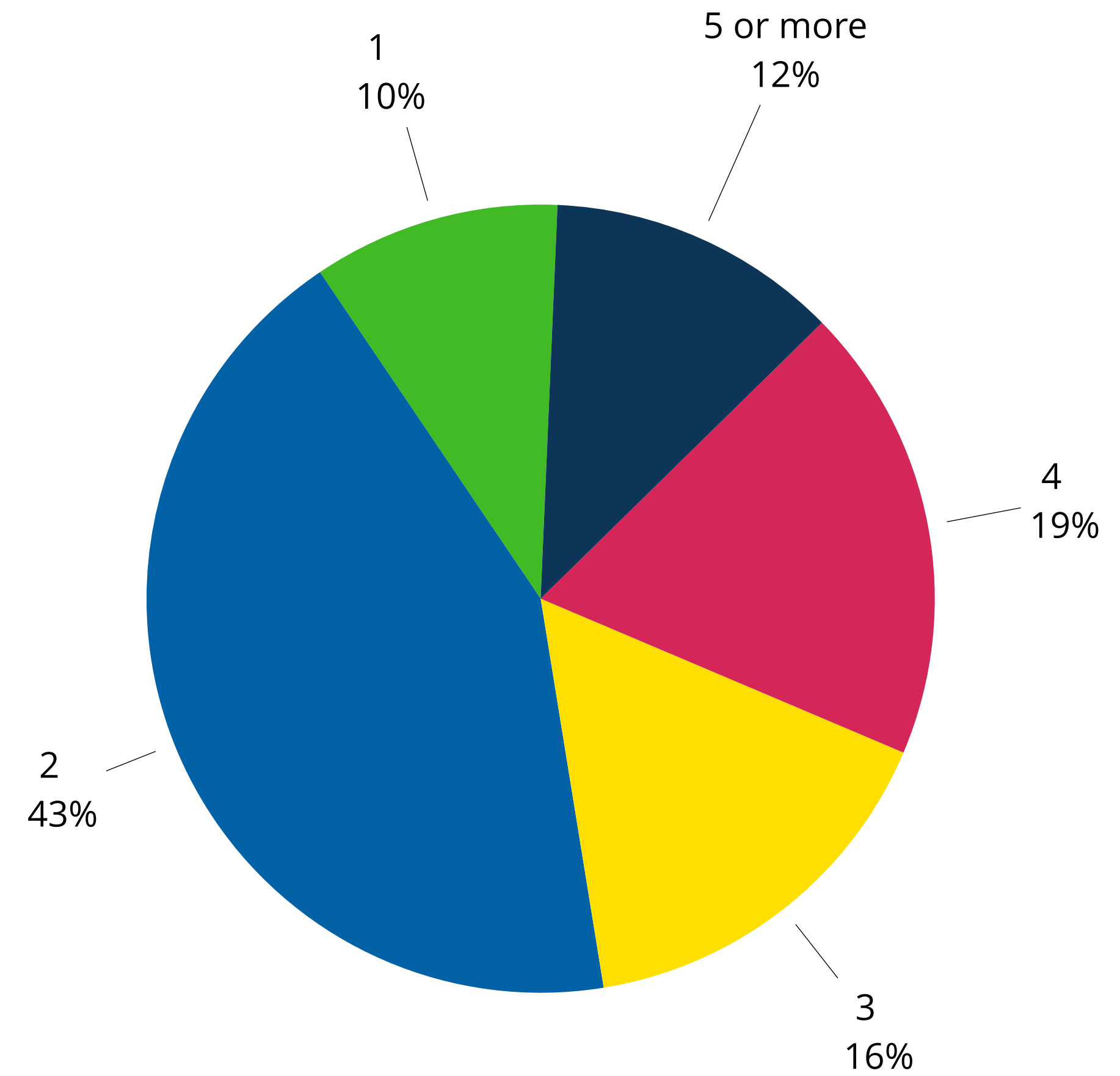
Residency

Participants were asked to indicate **how many years they have lived in Lethbridge.**



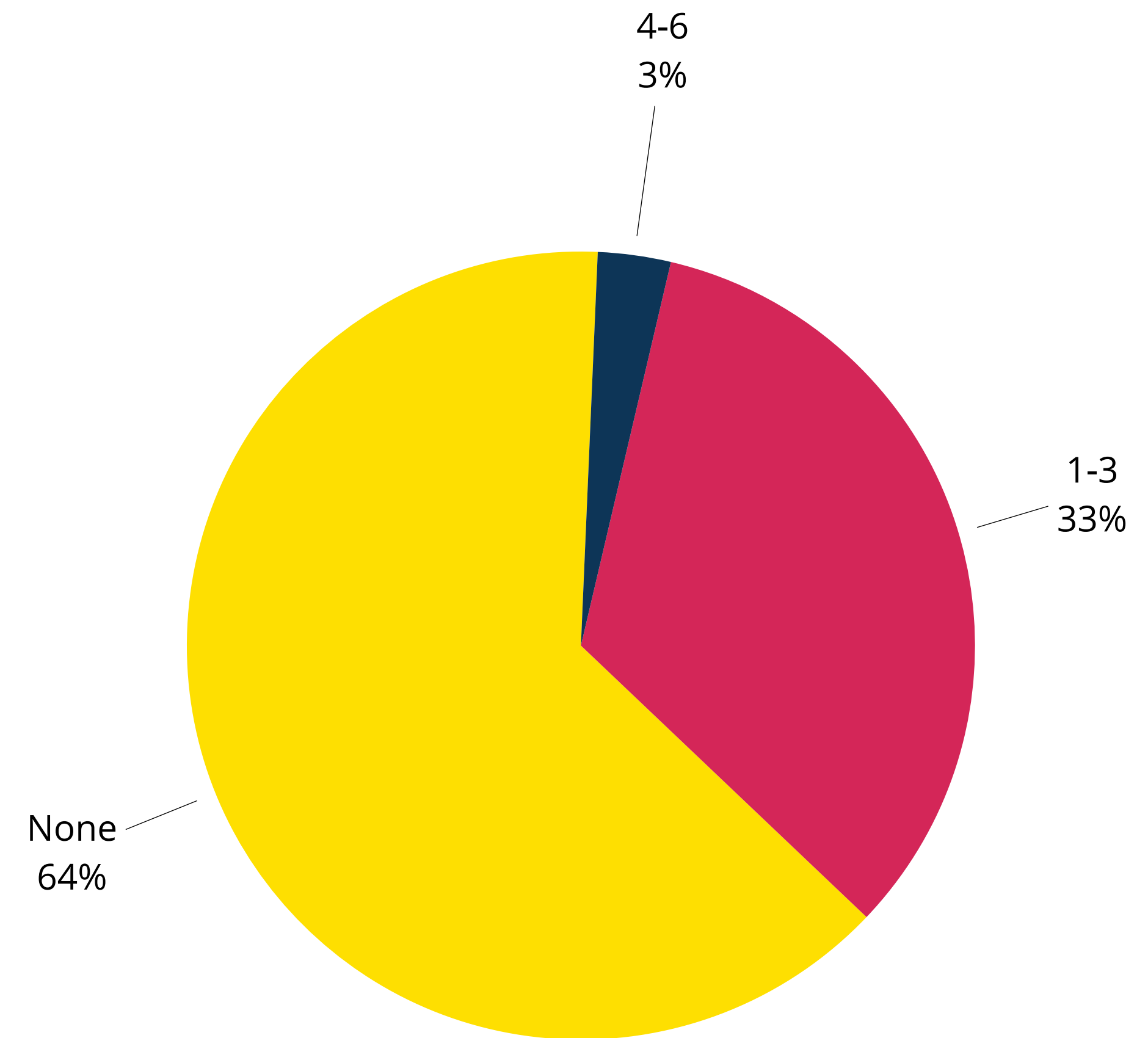
Household

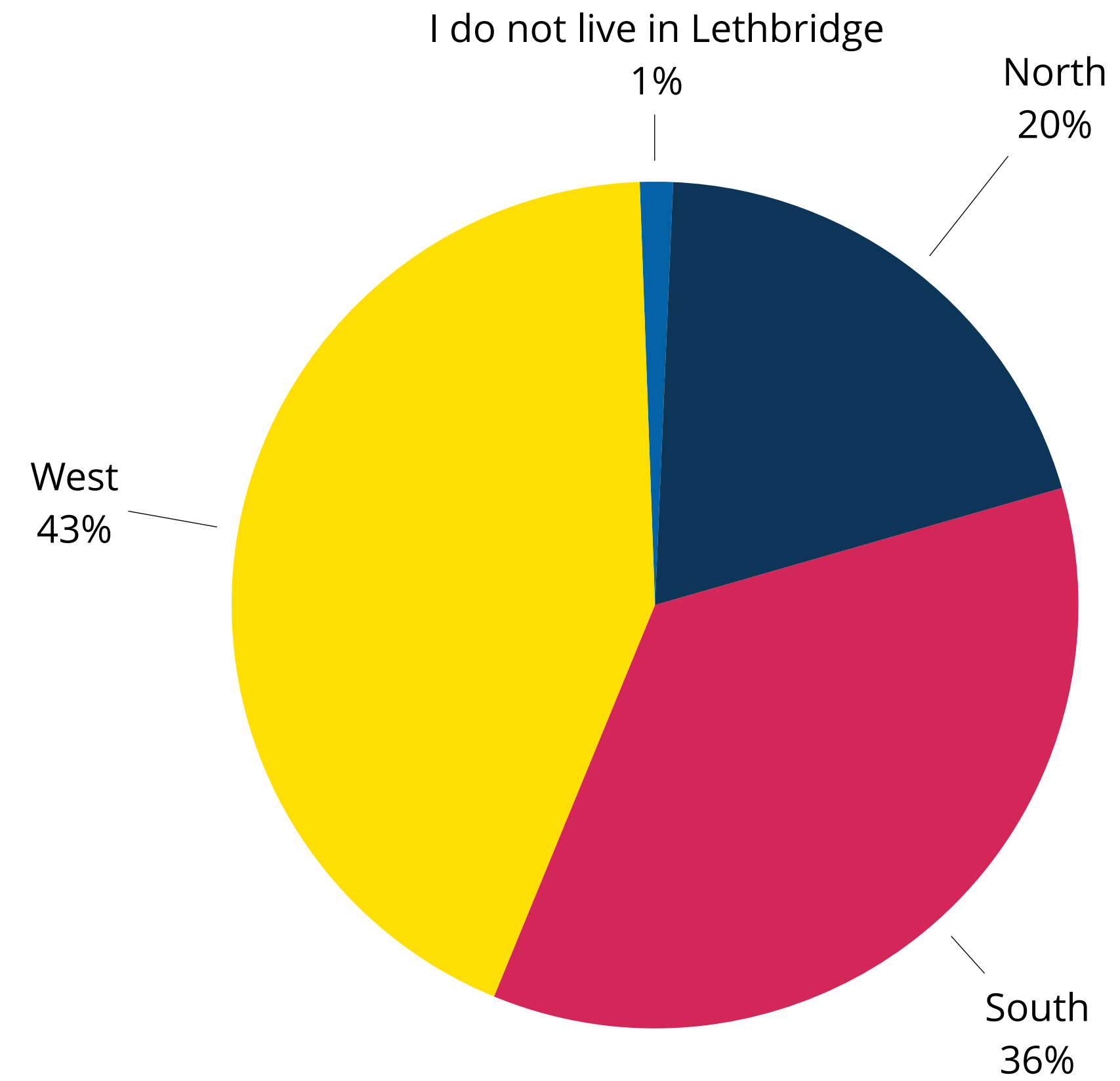
Participants were asked to indicate **how many people in household are under the age of 18.**

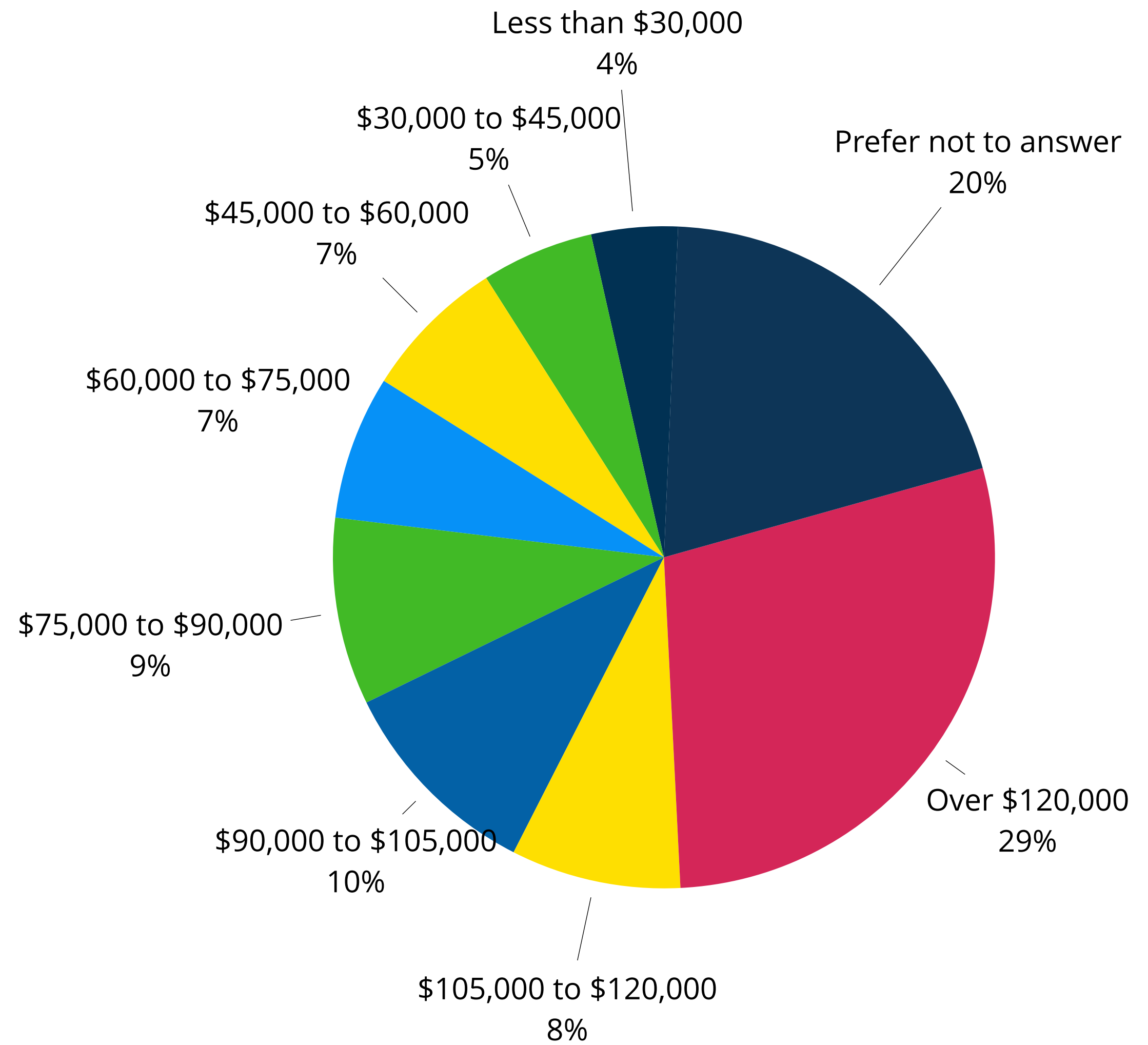
Residential Area

Participants were asked to indicate **which area of Lethbridge they live in.**



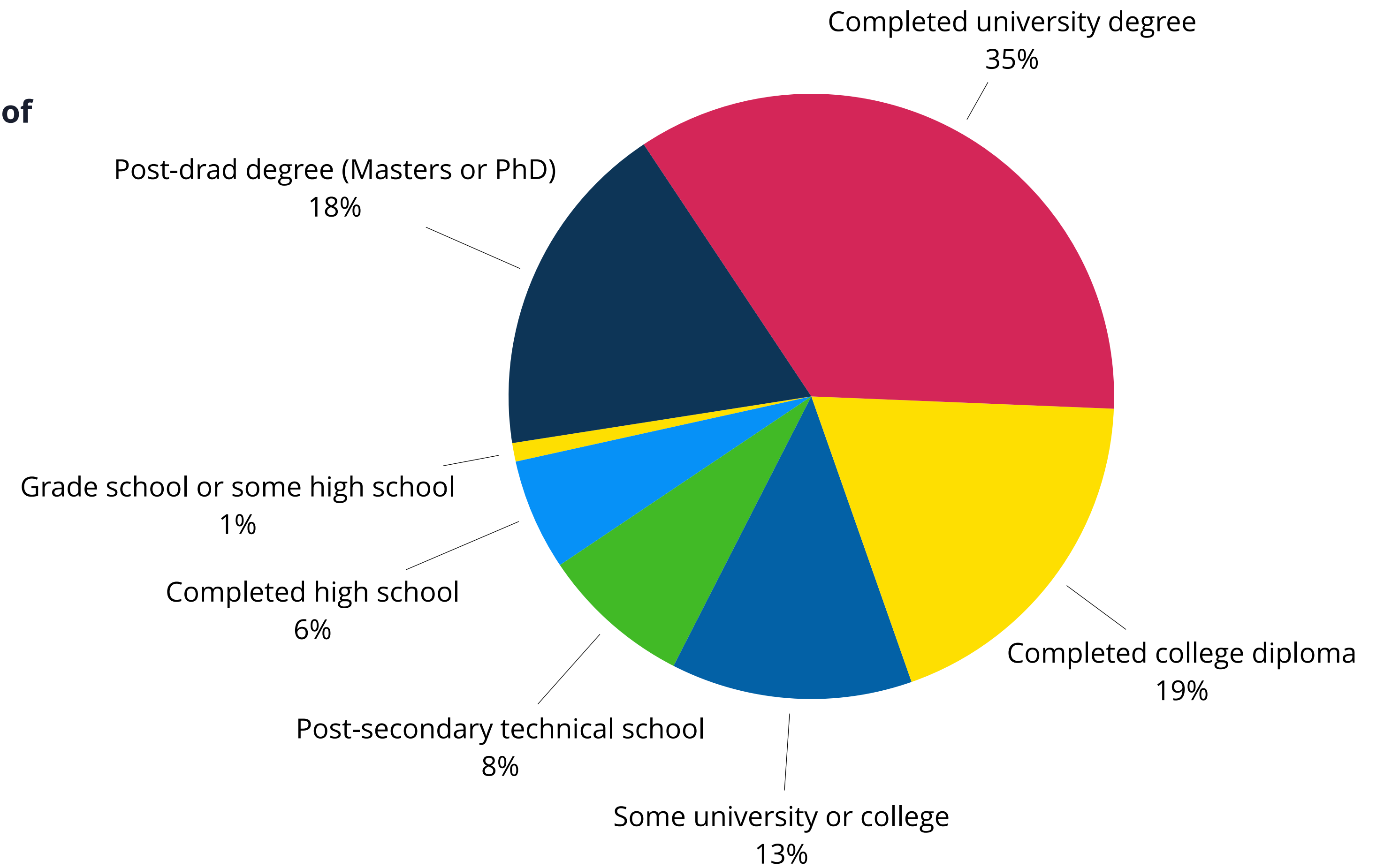
Income

Participants were asked to indicate **their income**.



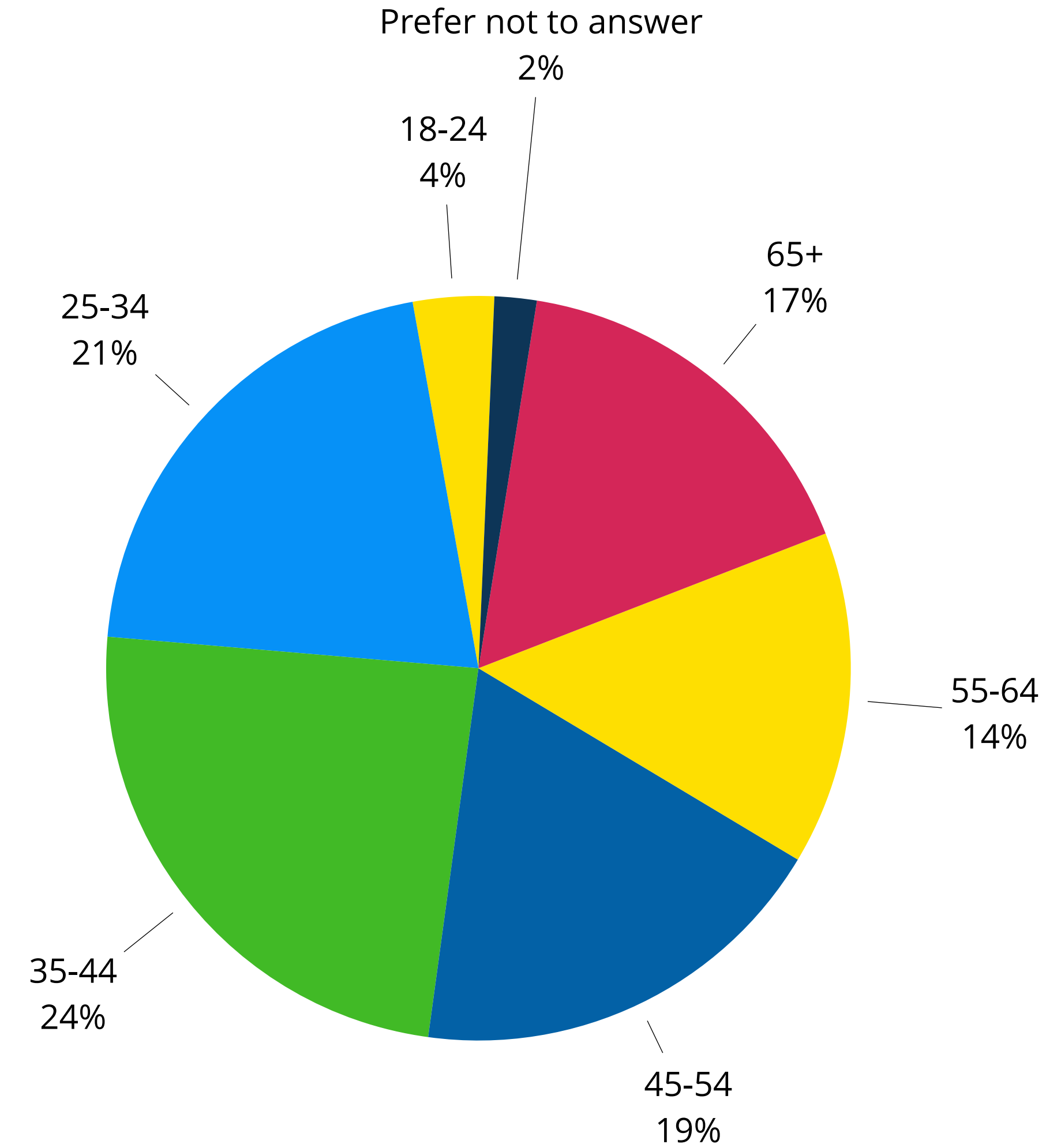
Education

Participants were asked to indicate the **highest level of education they have obtained.**



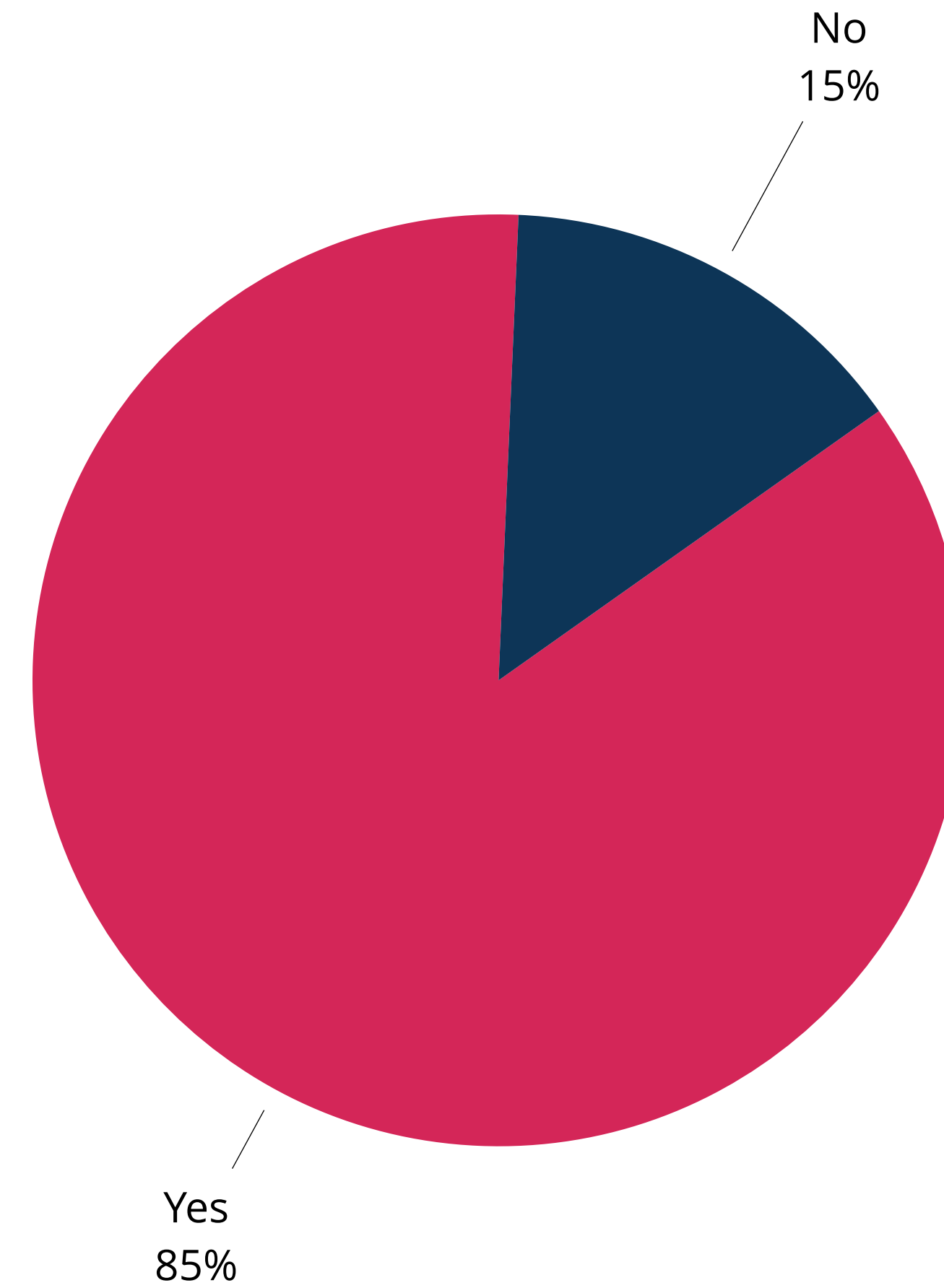
Age

Participants were asked to indicate their **age group**.



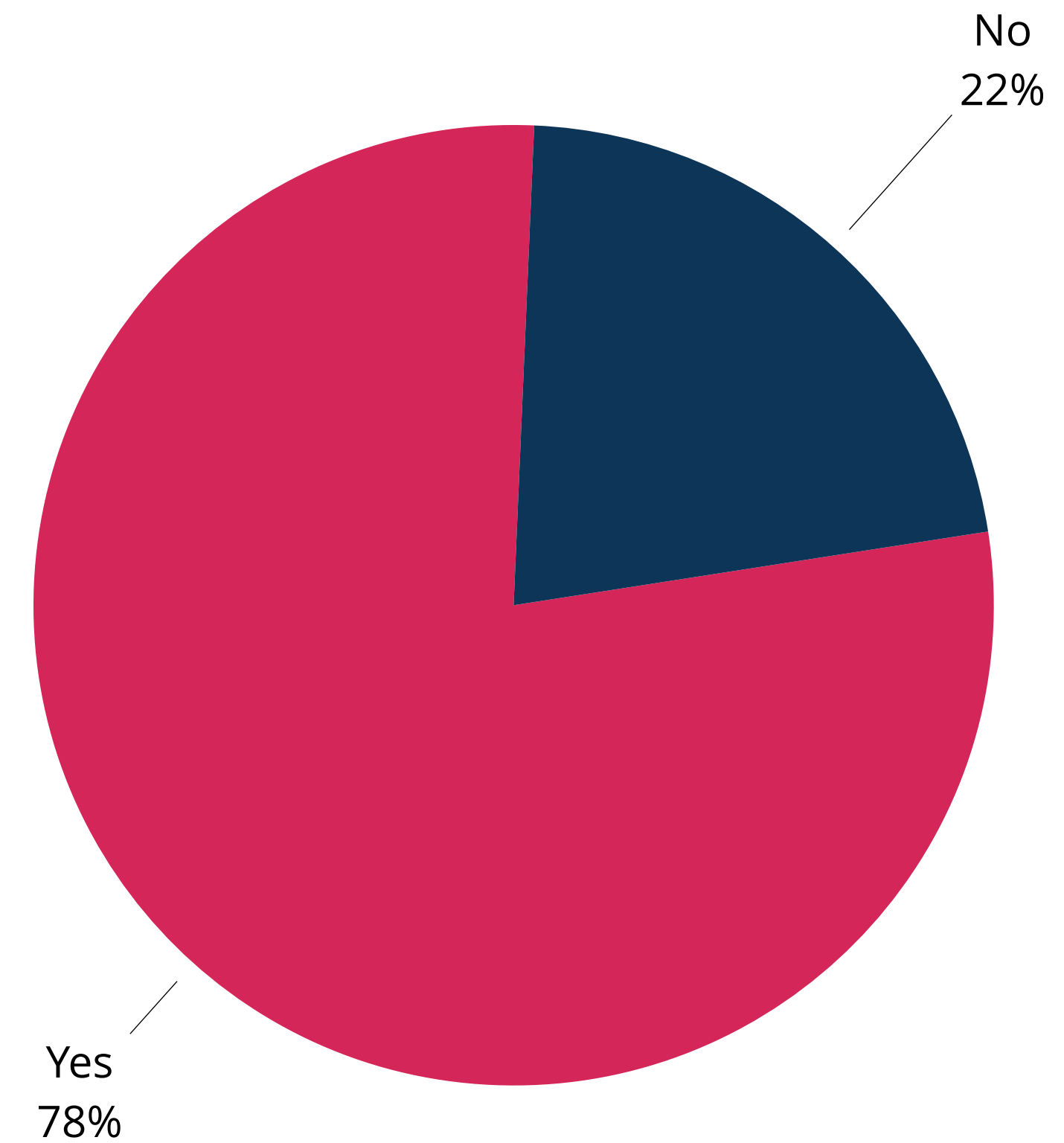
Friend Referral

Participants were asked to indicate if they would **refer this process to a friend**.



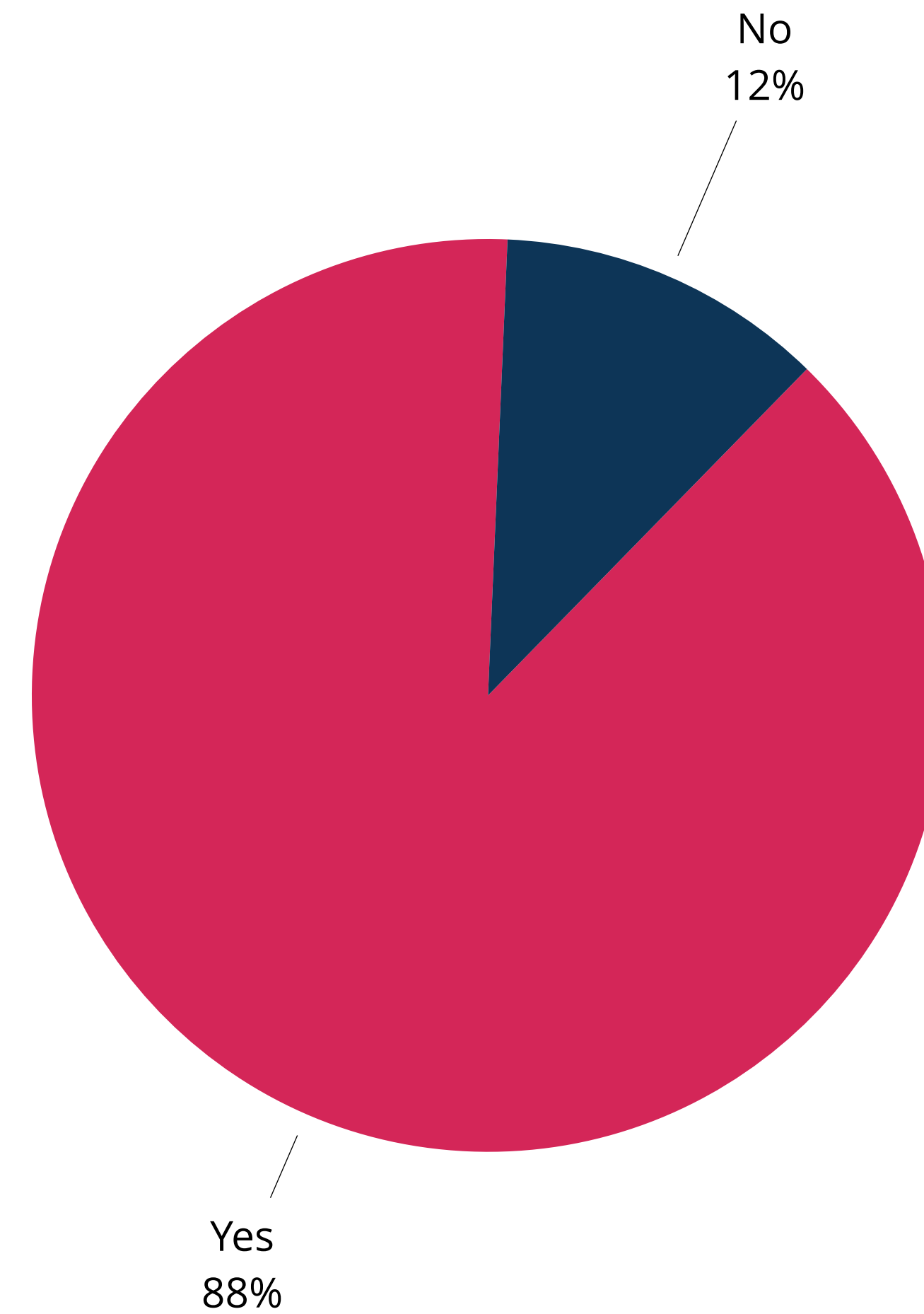

Participants were asked to indicate if they **learned anything new** by participating in this engagement process.



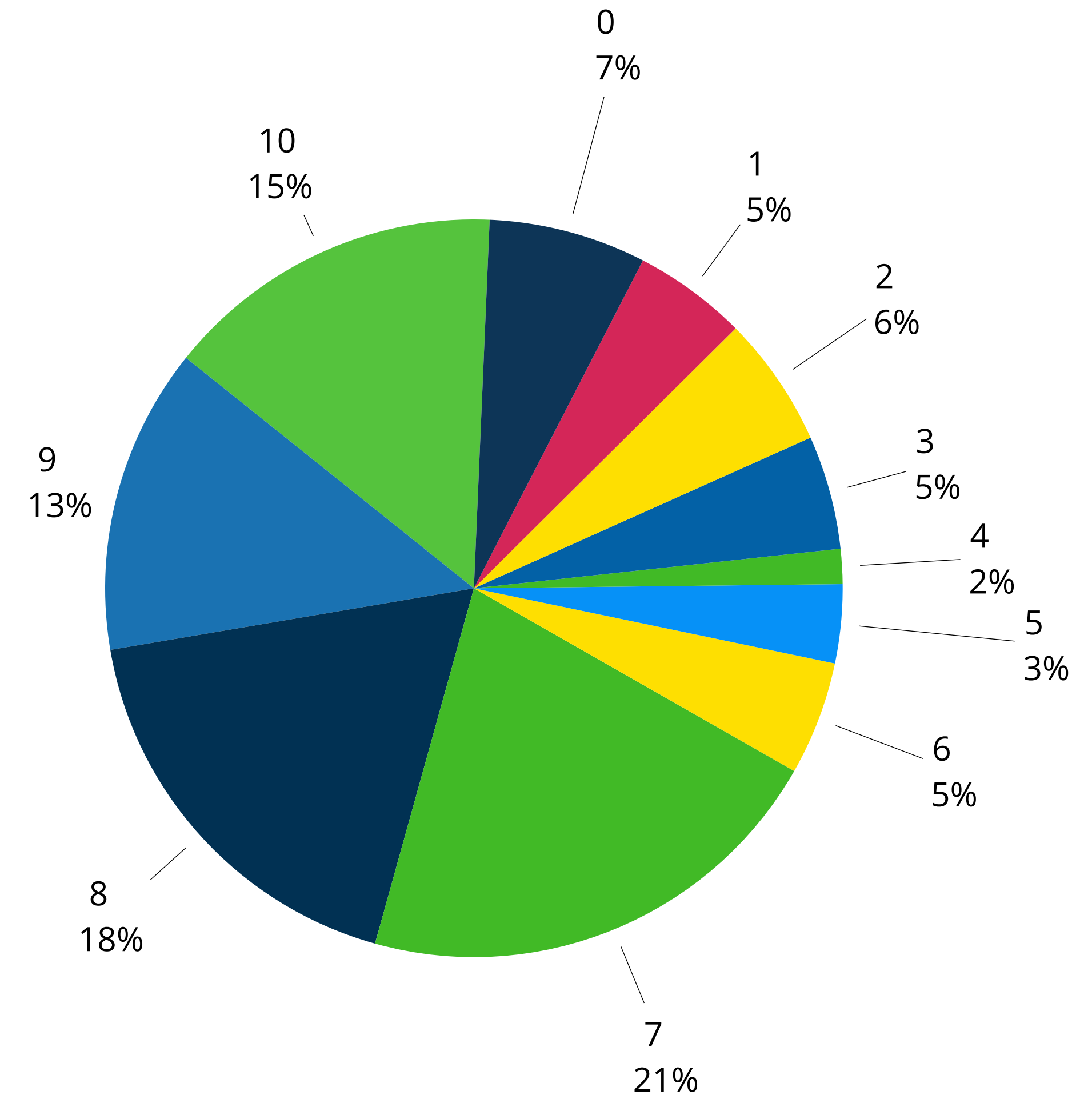

Participants were asked to indicate if they would like to see Ethelo used for other processes in their community.



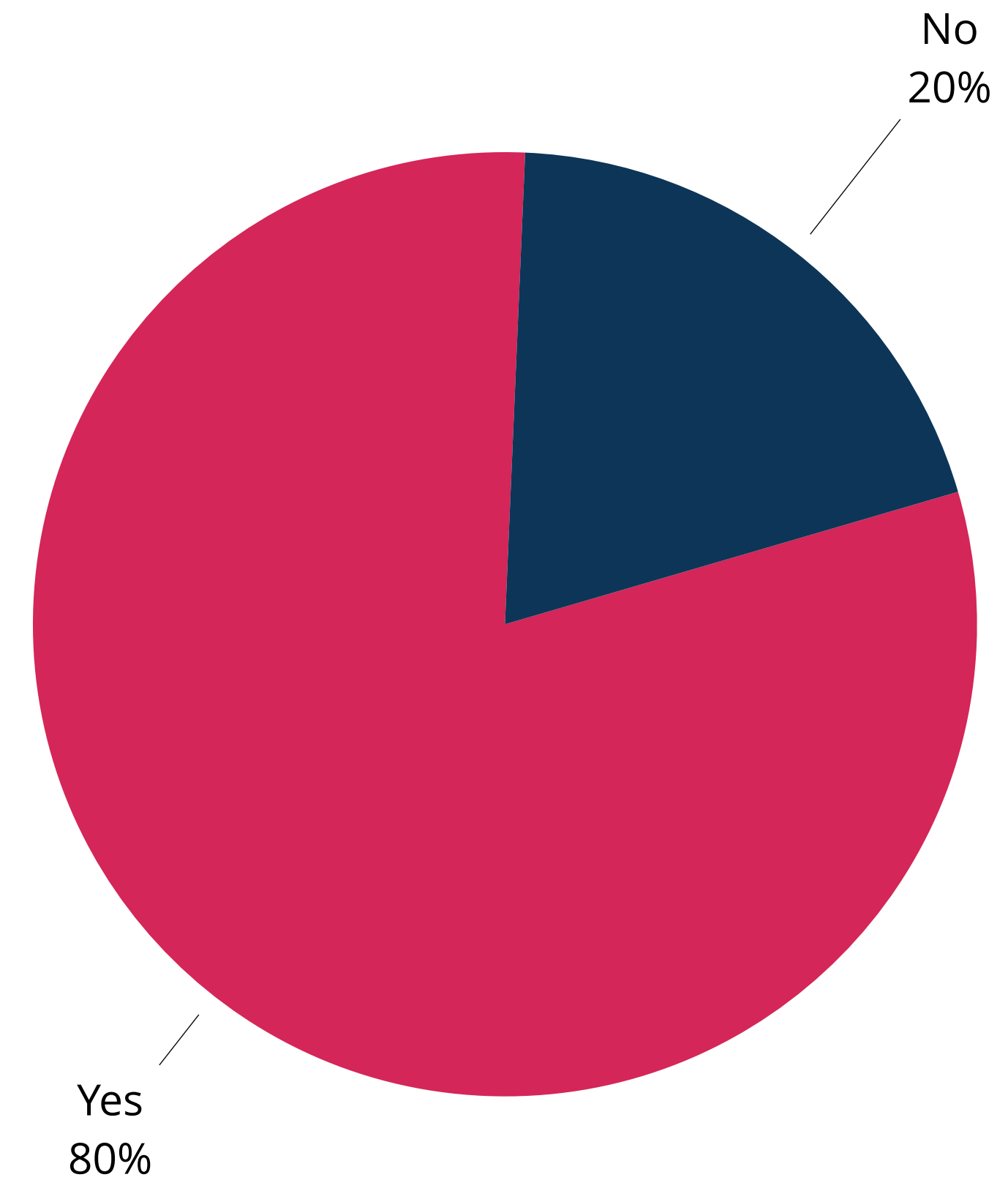
Process Evaluation
